**ORDINANCE NO. 2015-O-1**

**AN ORDINANCE RE-CODIFYING THE TOWN OF ALTA'S HUNTING RESTRICTIONS PURSUANT TO ORDINANCE 1993-O-4 WHICH RE-ENACTED PART 13-370 OF THE ORDINANCES OF THE TOWN OF ALTA AND AMENDING LANGUAGE TO ADDRESS AREAS ANNEXED INTO THE TOWN OF ALTA BOUNDARIES SINCE THE ADOPTION OF ORDINANCE PART 13-370.**

WHEREAS, in the interest of public safety, the Town of Alta, on August 12, 1993, passed Ordinance 1993-O-4 which reenacted 13-370 of the Ordinances of the Town of Alta defining areas in which bow and arrow hunting may lawfully occur;

WHEREAS, the Town of Alta received authorization to regulate hunting in this manner from the Wildlife Board of the State of Utah as required by Utah Law Section 23-14-1(3);

WHEREAS, after August 12, 1993, the Town of Alta has annexed additional lands on the north side of Little Cottonwood Canyon into the Town of Alta's boundaries;

WHEREAS, the Town of Alta has not yet taken action to restrict bow and arrow hunting on those later incorporated lands; and

WHEREAS, on December 9, 2010, the Town of Alta adopted and re-codified the Code of Ordinances in which, through an administrative error, failed to carry forward Ordinance 1993-O-4 which re-enacted Part 13-370 of the Ordinances of the Town of Alta into the new Ordinances.

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Alta as follows:

**SECTION 1. Section 1.** Amended Provisions: The following provisions of the Town Code are added, deleted or amended as follows: deletions are indicated by a strike through (e.g. ~~deletions~~) and changes and amendments are indicated by an underline. (e.g. underline).

5-3C-3 HUNTING RESTRICTIONS WITHIN TOWN LIMITS.

(A.) It shall be unlawful for any person to use, for the purposes of trapping, capturing or hunting any animal or bird of any type, in any area within the confines of the corporate limits of the Town of Alta, whether on public or private land, any gun, revolver, or firearm of any kind or nature, or airgun, flipper or bow and arrow, or any other such type of instrument designed to propel or throw missiles, or any spring gun, net, trap, snare or similar device, except that hunting with a bow and arrow shall be permitted on United State Forest Service property east and southeast of the Albion Basin Road and campground in accordance with all regulations promulgated by the State of Utah. Bow and arrow hunting shall additionally be permitted on the north side of the Twin Lakes Pass road, also known as Michigan City Road, and northeast portions of Grizzly Gulch to the connection with United States Forest Service property described above. It shall be unlawful to hunt, by any means, within the described areas

within 600 feet of the Albion Basin or Twin Lakes Pass roads, campground, or any home or cabin. The area within which the bow and arrow hunting may occur is identified, more specifically on the attached map, which is attached hereto as "Exhibit A" and incorporated herein by reference.

(B.) Nothing in this part shall prevent the owner of private property to post "NO HUNTING" notices on their lands as allowed by Utah Code.

(C.) Any violation of this section is a Class C misdemeanor.

**SECTION 2. Re-Numbered.** The remaining sections of this article are re-numbered sequentially.

**SECTION 3. Severability.** If any section, part, or provision of this Ordinance is held invalid or unenforceable, such invalidity or unenforceability shall not affect any other portion of this ordinance, and all section, parts, and provision of the Ordinance shall be severable.

**SECTION 4. Effective Date.** This ordinance shall become effective immediately upon posting in accordance with Utah law.
