

Open and Public Meetings Act - Meeting Minutes Compliance for School Districts and Charter Schools

Recently the question was asked if school districts and charter schools meet the definition of a 'state public body' as defined in the Open and Public Meetings Act in section 52-4-203(4)(a)(v). The Attorney General's office has determined that the legislature included language in various other statutes governing public schools and "local boards" which would include them in the definition of a 'state public body.' However, the legislature did not include similar language in the Utah Charter Schools Act and thus, charter schools are NOT a considered a 'state public body' as defined in this section.

What does this mean? Districts must follow section 52-4-203(4)(e) of the Open and Public Meetings Act, while Charter Schools must follow section 52-4-203(4)(g). The main difference is that Charter schools are not required to post their meeting minutes on the Utah Public Notice Website, but instead are required to only make them available to the public.

Districts:

- **Pending (draft)** meeting minutes must be made available to the public within 30 days after holding a meeting.
- An **audio recording** of a meeting must be **posted** to the Utah Public Notice Website within 3 days of the meeting.
- **Approved meeting minutes** must be **posted** to the Utah Public Notice Website within 3 days after approval.

Charter Schools:

- **Pending (draft)** meeting minutes must be made available to the public within a reasonable time after holding a meeting.
- An **audio recording** of a meeting must be **made available** to the public within 3 business days of the meeting.
- **Approved meeting minutes** must be **made available** to the public within 3 business after approval.

Notice of Meetings: Both districts and charters schools are required to **post notice of meetings** on the Utah Public Notice Website at least 24 hours before a meeting in

compliance with UCA 52-4-202.

Alert to Auditors of Local Governments: Please note that the information above regarding charter schools in Chapter 1, Section K, step 2. d. of the State Compliance Audit Guide, should be modified for charter schools to instead read "Determine that within three days of the meeting minutes being approved, the minutes were made available to the public."

Chapter 4 Open and Public Meetings Act

Part 2 Meetings Section 203 Written minutes of open meetings -- Public records -- Recording of meetings.

(Effective 5/13/2014)

4. (i) **A specified local public body shall:**

- (f) (A) make pending minutes available to the public within **30 days** after holding the open meeting that is the subject of the pending minutes;
- (B) subject to Subsection (4)(f)(ii), **within three business days after approving written minutes of an open meeting, post to the website** and make available to the public at the public body's primary office a copy of the approved minutes and any public materials distributed at the meeting; and
- (C) **within three business days after holding an open meeting, make an audio recording of the open meeting available to the public for listening.**
