**A RESOLUTION OF THE CITY OF TAYLORSVILLE APPROVING THE LIST OF  
APPOINTED POLL WORKERS FOR THE 2015 MUNICIPAL GENERAL ELECTION  
FOR TAYLORSVILLE, UTAH**

**WHEREAS**, the Taylorsville City Council (the "Council") met in regular session on October 7, 2015, to consider, among other things, approving the list of appointed poll workers for the 2015 Municipal General Election for Taylorsville, Utah; and

**WHEREAS**, UTAH CODE ANN. § 20A-5-602 provides, among other things, that the municipal legislative body shall appoint or provide for the appointment of individuals to serve as poll workers during municipal elections; and

**WHEREAS**, the attached list of appointed poll workers has been provided by Salt Lake County for the 2015 Taylorsville Utah General Election; and

**WHEREAS**, the Council acknowledges that the attached list of appointed poll workers, as provided by Salt Lake County, may be subject to change; and

**WHEREAS**, the Council has determined that it is in the best interests of the citizens of Taylorsville to provide for the appointment of individuals to serve as poll workers during municipal elections.

**NOW, THEREFORE, BE IT RESOLVED** by the Taylorsville City Council that the attached list appointing individuals to serve as poll workers in the 2015 Taylorsville Utah General Election is hereby approved and that such list may be modified from time to time by the election officer for unforeseen circumstances, provided such changed appointments satisfy the requirements of state statute.

This Resolution, assigned Resolution No. 15-26, shall take effect immediately upon passage and acceptance as provided herein.
