MIKE CALLS MEETING TO ORDER. ALL APPLICATES AS WELL AS THE STATE ARE SWORN IN. MOTION TO APPROVE MINUTES FROM LAST MEETING MIKE, CHRIS SECONDS. UNANIMOUS.

AGENDA.

BATCHELOR TUKUMOEATU- JEFF STATES THAT MR TUKUMOEATU'S PERMIT WAS DENIED BASED ON A 2015 ASSULT CONVICTION AS WELL AS CURRENTLY SERVING 18 MONTHS PROBATION. MR TUKUMOEATU THEN STATES THAT HE IS GREATFUL FOR THIS OPPORTUNITY TO BE HERE BEFORE THE BOARD. STATES THAT IN APRIL OF 2015 HE AND HIS WIFE WERE INVOLVED IN AN AUTO ACCIDENT. CLAIMS THAT HE WAS CUT OFF AND HIT A BOX VAN TO AVOID HITTING FURTHER CARS. MR TUKUMOEATU STATES THAT HIS WIFE WAS STUCK IN THE CAR UNABLE TO GET OUT. ON THE DAY IN QUESTION HE FORGOT WHO HE WAS, APPROCD THE CAR THAT CAUSED THE ACCIDENT AND PROCEEDED TO BEAT HIM UP. INFORMS BOARD THAT HE IS CURRENTLY ATTENDING ANGER MANAGEMENT CLASSES, HAS ONE MORE LEFT. HE NOW CAN SEE THE BIG PICTURE, KNOWS WHAT HE DID WAS WRONG. SHOULD HAVE LEFT IT UP TO LAW ENFORCEMENT. WOULD LIKE PERMIT TO PROTECT HIMSELF AS WELL AS HIS FAMILY. MOTION TO UPHOLD THE STATE CLARK, CHRIS SECONDS. UNANIMOUS. UPHELD.

JOSH READ- JEFF STATES THAT MR READ'S RENEWAL PERMIT WAS DENIED BASED ON A 2014 IMPAIRED DRIVING CONVICTION. MR READ THEN STATES THAT IN 2013 HE RECEIVED A IMPARIED DRIVING TICKET. WAS WORKING AND GOING TO SCHOOL. HAD TAKEN A VALUM FOR HIS BACK PAIN. STATES THAT HE HAD SURGERY NOT TO LONG PRIOR TO THE CHARGE. INFORMED THE OFFICER THAT HE DID IN FACT HAVE A PRESCRIPTION FOR THE DRUG. CLAIMS THAT HE WAS CHECKED OUT AT THE SCENE, THEN AGAIN AT THE HOSPITAL. HAD VERY HIGH BLOOD PRESSURE. STATES THAT SHE WAS PULLED OVER UPON LEAVING THE BAR AT THE FRIST LIGHT. CLAIMS THAT SHE DID THE FIELD TEST, AND FELT LIKE SHE DID WELL. IT TOOK 5 OR 6
