A RESOLUTION OF THE CITY OF SOUTH SALT LAKE CITY COUNCIL GRANTING PERMISSION FOR THE POLICE DEPARTMENT TO APPROPRIATE CERTAIN PROPERTY IN ITS POSSESSION TO PUBLIC INTEREST USE.

WHEREAS, the South Salt Lake City Police Department has acquired possession of various firearms (lists of which are attached to this resolution) as evidence, found property, or for safekeeping, is authorized pursuant to state law to dispose of the property, has made reasonable efforts to identify and notify owners of the property, and has either been unsuccessful in determining ownership over the property, or has been successful in determining ownership over the firearm but the owner cannot legally possess the firearm under the law, or has notified the apparent owner and has not received a timely response;

WHEREAS, Utah Code permits the City Council to authorize the appropriation of this property to public use by auctioning or selling the items; and

WHEREAS, the City has published notice of the potential appropriation of this property, and will provide adequate time for the public to respond to this notice,

BE IT RESOLVED, therefore, by the City Council of the City of South Salt Lake that, pursuant to Utah Code Ann. §§ 24-3-103 & 77-24a-5, the firearms identified on the lists accompanying this resolution may be appropriated for public interest use by: (1) selling or trading in the firearms identified on the lists to Shooter's World, and (2) transferring the identified monies to the general fund for expenditure on city services and obligations.
