

**RESOLUTION NO. 2015-05**

**CANVASS OF THE 2015 MUNICIPAL ELECTIONS  
ADOPTED NOVEMBER 10, 2015**

A resolution of the City Council of Kamas City, canvassing the returns of the Municipal Election held on November 3, 2015 for the position of three City Council seats and declaring the result thereof.

BE IT KNOWN AND REMEMBERED:

- (1) The City Council, of Kamas City, (The City), called an Election and directed that it be held on November 3, 2015 as per Utah State Law, for the purpose of electing three City Council seats to the City for a term of four years each (the Election).
- (2) The City Council, acting as the Board of Canvassers, has reviewed all matters and action taken relating to the holding and conduct of the Election and is ready to declare the results thereof,

NOW, THEREFORE, the City Council acting in its capacity as the Board of Canvassers (the Board) of the Election, hereby resolves AS FOLLOWS:

Section 1. The Board hereby finds and determines, (1) that the Election was duly and properly called, (2) that public notice of the Election was published and posted as provided by law, (3) that three judges of election were appointed prior to the Election and charged with the conduct of the Election, (4) that one voting precinct was designated for the Election consisting of all the territory within boundaries of Kamas City, (5) that the Notice of Election prescribed and advertised the time and place of Election, the polling place, the hours of opening and closing of the polls, the qualifications of voters and other details of the Election, and, (6) that the Election was duly and properly held and the returns thereof have been made, delivered and canvassed, all in accordance with and as prescribed by the Election laws of the State of Utah.

Section 2. Pursuant to the canvass of election returns, the Board finds that the following votes were cast by the qualified voters of The City who voted in the Election:

Section 3. The City Council acting as the Board of Canvassers of the Election, finds, determines, and declares the foregoing as accurate and final as the official results for the 2015 Kamas City Municipal Election.
