**A RESOLUTION CERTIFYING THE CANVASS OF THE

**WHEREAS**, the Board publicly canvassed the returns and determined from the returns the vote of each voting precinct for each person voted for.

**NOW THEREFORE, BE IT RESOLVED** by the Board of Municipal Canvassers for the City of Taylorsville, Utah as follows:

1. The Board hereby certifies and approves the election results for the 2015 Taylorsville Municipal General Election held November 3, 2015.
