

**SANPETE COUNTY COMMISSION MEETING**

**September 15, 2015, 2:00 P.M.**

Sanpete County Courthouse, 160 North Main, Room 101, Manti, Utah

Present are: Commission Chair Claudia Jarrett, Commissioners Steve Frischknecht and Scott Bartholomew, and County Clerk Sandy Neill. County Attorney Brody Keisel is excused.

Meeting is called to order by Commission Chair Claudia Jarrett.

**CLAIMS**

Deputy Auditor Suzaun Richardson is present. Motion is made by Commissioner Frischknecht to approve payment of claims #336924 through #337041. The motion is seconded by Commissioner Bartholomew, and the motion passes.

**RATIFICATION OF APPROVAL OF MODIFICATION OF GRANT OR AGREEMENT BETWEEN SHERIFF'S OFFICE AND MANT-LASAL NATIONAL FOREST**

Sheriff Brian Nielson is present. The funds for this grant were set to decrease. Instead, a modification was made and funds were increased slightly. Motion is made by Commissioner Bartholomew to ratify the approval done on September 2, 2015. The motion is seconded by Commissioner Frischknecht, and the motion passes. The funds will be used for supplies for tasers.

**SHERIFF BRIAN NIELSON: APPROVAL TO GO TO THE ROSTER TO HIRE A DEPUTY**

Motion is made by Commissioner Frischknecht to approve opening the roster to recruit another deputy. The motion is seconded by Commissioner Bartholomew, and the motion passes.

**APPROVAL TO PAY SEARCH AND RESCUE FOR THREE RESCUES: STRANDED MOTORIST - SKYLINE DRIVE; MEDICAL ASSIST UP SIX MILE CANYON; MAPLE CANYON RESCUE**

Motion is made by Commissioner Frischknecht to approve the payment of \$216.50 for the stranded motorist on Skyline Drive rescue. The motion is seconded by Commissioner Bartholomew, and the motion passes. Motion is made by Commissioner Frischknecht to approve the payment of \$1,293.65 for the medical assist up Six Mile Canyon. The motion is seconded by Commissioner Bartholomew, and the motion passes. Motion is made by Commissioner Bartholomew to approve the payment of \$2,089.50 for the Maple Canyon rescue. The motion is seconded by Commissioner Frischknecht, and the motion passes. The funds come from Title III.

**APPROVAL TO HIRE EARL CLARK AS A PART-TIME EMPLOYEE**

Motion is made by Commissioner Frischknecht to approve hiring Earl Clark as a part-time employee without benefits at the rate of \$19.08 per hour effective September 3, 2015. The motion is seconded by Commissioner Bartholomew, and the motion passes. The auditor will watch Mr. Clark's hours to be sure it doesn't cause problems with his retirement.

**APPROVAL OF MASS GATHERING PERMIT FOR DESERT BRATS RACING**

Motion is made by Commissioner Bartholomew to approve the mass gathering permit in Indianola off Highway 89 (Big Hollow Road) for Desert Brats Racing on October 31, 2015. The motion is seconded by Commissioner Frischknecht, and the motion passes.

**APPROVAL TO PAY ECO LIFE FOR MOSQUITO CONTROL**

Motion is made by Commissioner Frischknecht to approve the payment of \$9,145.80 to EcoLife for mosquito control. The motion is seconded by Commissioner Bartholomew, and the motion passes.

**APPROVAL TO PAY AMERICAN SECURITY CABINETS FOR BALLOT DROP BOXES**

Motion is made by Commissioner Frischknecht to approve the payment of \$8,474 to American Security Cabinets for ballot drop boxes. The motion is seconded by Commissioner Bartholomew, and the motion passes.

**APPROVAL OF RIGHT OF WAY PERMIT FOR GTELCO TO INSTALL LINES IN AXTELL**

Commissioner Bartholomew abstains due to a conflict. Motion is made by Commissioner Frischknecht to approve the right of way permit for GTELCO to install lines in Axtell. The motion is seconded by Commissioner Jarrett, and the motion passes.

**APPROVAL OF RIGHT OF WAY PERMIT FOR WAYNE SORENSEN TO INSTALL IRRIGATION ON CLARION ROAD**

Motion is made by Commissioner Bartholomew to approve the right of way permit for Wayne Sorensen to install irrigation on Clarion Road pending a bond being posted. The motion is seconded by Commissioner Frischknecht, and the motion passes.

**APPROVAL OF RIGHT OF WAY PERMIT FOR QUESTAR GAS TO INSTALL GAS MAIN NEAR MANTI**

Motion is made by Commissioner Bartholomew to approve the right of way permit for Questar Gas to install gas main at 0180 S 0740 E near Manti. The motion is seconded by Commissioner Frischknecht and the motion passes.

**APPROVAL OF MINUTES**

Motion is made by Commissioner Bartholomew to approve the minutes from September 1, 2015 with minor corrections. The motion is seconded by Commissioner Frischknecht, and the motion passes.
