**ISSUE SUMMARY:**

Utah Code Ann. § 10-3-916 requires that the mayor shall appoint a qualified person to the office of city treasurer with the advice and consent of the city council. This appointment must be made on or before the first Monday in February following a municipal election. A municipal election was conducted in November 2015; thus, it is necessary for the mayor to appoint a city treasurer. Mayor Lawrence Johnson therefore nominates John Taylor as city treasurer.

**WHEREAS**, the Taylorsville City Council (the "Council") met in regular session on January 6, 2016, to consider, among other things, approving the appointment of John Taylor as city treasurer; and

**WHEREAS**, UTAH CODE ANN. § 10-3-916 provides that the mayor shall appoint a qualified person to the office of city treasurer, with the advice and consent of the city council, on or before the first Monday in February following a municipal election; and

**WHEREAS**, a municipal election was held on November 3, 2015; and

**WHEREAS**, the mayor therefore hereby nominates John Taylor as city treasurer; and

**WHEREAS**, the Council has given advice for and consents to such appointment; and

**WHEREAS**, after careful consideration, the Council has determined that it is in the best interests of the health, safety and welfare of the citizens of the city of Taylorsville to consent to the appointment of John Taylor as city treasurer.

**NOW, THEREFORE, BE IT RESOLVED** that the Taylorsville City Council hereby approves the appointment of John Taylor as city treasurer.

This Resolution, assigned Resolution No. 16-02, shall take effect immediately upon passage and acceptance as provided herein.
