**Parrish Lane Sidewalk & Fencing Projects
Financial Summary – 2/16/16 (revised)**

Note: This analysis assumes the Council awards the fencing bids as recommended by the City Engineer, Kevin Campbell, in his 2/12/16 email.

53,000.00	Engineering (approx. 15% of ACME bid)
18,000.00	Administrative Fee (approx. 5% of ACME bid)
65,967.00	Fence credit for standard chain link—on 2 bridges and along N. side of Parrish
<u>6,200.00</u>	Remaining aesthetic credit assigned to ped bridge

Recommendation

- After all costs are finalized, and after removing the \$18,000 Administrative Fee from the funds available, apply any surplus to reduce the contribution from the RDA—i.e. the RDA’s contribution could be less than \$120,000. Leave the \$18,000 in the Capital Improvement Fund to be used for streets/sidewalks.

Comparison of First and Second Bid Outcomes—for option that includes Majestic fence

- December 10, 2015 bid results—total bid if awarded for entire length: \$ 255,745.50
- February 11, 2016 bid results—total as recommended by City Engineer: \$ 179,746.06
