The following recommendations of the Utah Professional Practices Advisory Commission (UPPAC) are transmitted for review and action by the Utah State Board of Education:

- **Case No. 15-1272**
UPPAC recommends the Board suspend the educator’s Level 2 Secondary Education license for a period of no less than four (4) years consistent with the Stipulated Agreement. Reinstatement, following a UPPAC hearing and recommendation is subject to Board approval.

The following recommendations of the Utah Professional Practices Advisory Commission (UPPAC) are transmitted for review by the Utah State Board of Education:

- **Case No. 15-1257**
The Executive Secretary recommends the Board suspend the educator’s Level 2 Secondary Education License for a period of five (5) years consistent with the terms of the Default Order. Reinstatement, following a UPPAC hearing and recommendation, is subject to Board approval.
