REQUEST

Consideration of the 2016 Utah County Municipal Recreation Grant Agreement.

BACKGROUND AND DESCRIPTION

The Parks and Recreation Department would like to apply for a Utah County Municipal Recreation Grant for the amount of \$ 4,899.33. The grant must be used for projects that involve the development or construction of tourism, recreation, or cultural facilities. This year the grant will be used to help purchase new swing benches to be placed in the parks and possibly along the new trail.

RECOMMENDATION: That the Mapleton City Council authorize the Mayor to sign the Utah County Municipal Recreation Grant Application.

Mapleton City New Park Swing Benches 2016

Mapleton's beautiful city parks are popular places for recreation. Our parks host several sporting events, family reunions, company parties, school field trips, and other social gatherings. Mapleton City has recently started to place new swing benches throughout the parks (please see attached drawings and pictures). These benches have become very popular with the visitors in our parks.

The scope of this year's project, is the purchase and installation of three new Swing Benches to be located in Mapleton City's Ira Allan Sports Park (2000 South 800 West, Mapleton) and along the new Mapleton Lateral Canal Parkway Trail that will be opened by July 2016.

Sonntag Recreation has estimated the cost for one swing bench (including shipping) to be approximately \$ 1,796.67.

The total amount to purchase the three swing benches would be \$5,390.00.

Additional funds have been budgeted for the concrete and installation of the Swing Benches.

Upon delivery of the benches, the projects will take approximately 1-2 weeks to finalize.
