A RESOLUTION OF THE REDEVELOPMENT AGENCY OF TAYLORSVILLE CITY BOARD ADOPTING A FINAL BALANCED BUDGET FOR THE FISCAL YEAR BEGINNING JULY 1, 2016 AND ENDING JUNE 30, 2017

WHEREAS, on May 4, 2016, the Redevelopment Agency of Taylorsville City Board (the “Board”) met in a properly noticed meeting to consider, among other things, tentatively adopting a tentative balanced Redevelopment Agency of Taylorsville Budget for the 2016-2017 fiscal year (the “Tentative Budget”), a copy of which is attached hereto; and

WHEREAS, on May 6, 2016, notice of public hearing to consider the Tentative Budget was published in the *Salt Lake Tribune* and the *Deseret Morning News*; and

WHEREAS, on May 6, 2016, notice of public hearing to consider the Tentative Budget was published on the Utah Public Notice Website; and

WHEREAS, on May 6, 2016, the Tentative Budget was made available for public inspection; and

WHEREAS, on May 18, 2016, a public hearing to receive public comment and consider adoption of a final balanced budget was held at 7:00 p.m. in the Council chambers located at 2600 West Taylorsville Boulevard, Taylorsville, Utah; and

WHEREAS, all interested persons in attendance at the public hearing were given an opportunity to be heard, for or against, the estimated revenues and expenditures, or any other item thereof in the Tentative Budget; and

WHEREAS, the Board has determined that adopting the Tentative Budget with any amendments the Board has directed is in the best interest of the City, its residents and businesses; and

WHEREAS, the Board desires to adopt the Tentative Budget as its 2016-2017 Fiscal Year Budget.

NOW, THEREFORE, BE IT RESOLVED that the Redevelopment Agency of Taylorsville City Board hereby adopts the Tentative Budget as presented to the Board as its 2016-2017 Fiscal Year Budget.
