QUALIFICATIONS TO VOTE

U.S. Citizen, resident of the State of Utah for over 30 days preceding election, 18 years of age by June 28, 2016, and registered to vote in Box Elder County.

You must present a valid form of identification to the poll worker at the time you vote.
