Commissioner Millburn addressed Commissioner Petroff saying "It has been a pleasure and an honor to work alongside you and get to know you, not only as a fellow commissioner and co-worker, but as a very dear friend. This isn't going to be the same without you. You are truly going to be missed. Your influence and mark will be felt for decades to come. We wish you, Pam and the rest of your family very well and hope that you and they are able to enjoy some great times together. Please don't forget us here. Come back to visit. I know where to at least find you in the warmer months (golf course). Maybe we can make you an honorary field inspector of the golf courses. A fairway and green inspector. It truly has been a real honor to work with you." He presented Commissioner Petroff with a Davis County buffalo with an affixed Davis County coin which reads 'In recognition of your support and efforts on behalf of Davis County.' This is a small token of our appreciation. You know our hearts are much fuller than that."

Commissioner Smith said that he "has never worked with a group of 3 who have worked so well together. Commissioner Petroff really went out of his way to help me get oriented when I came on board. It is tougher than you think. I consider him a friend and a mentor. I have absolutely loved this opportunity to work and hang around you. You're a great guy. You're fun to be with. There is a lot of depth of character, wisdom, intelligence, experience and he's just got a great heart. It has been a joy to work with him. I consider him and Pam friends for a lifetime. I absolutely love JP!"

Commissioner Petroff was also presented a portrait of himself with his wife Pam that was taken at his farewell open house earlier in the month.

Commissioner Petroff spoke saying, "We have had around 400 Commission Meetings since I've been on the Commission, which is about 50 per year for 8 years, if my math is right. I think Chief Kevin Fielding (Sherriff's Office) has been at every one of them. Looking at the agenda today it appears that no records will be set for having the shortest meeting. It is hard to explain what it is like when you've had your career and your life's work. When I had my own business of 30+ years, somewhere along the line I got drug into politics that started in 1999. For the last 15 years, I have served as a mayor or a commissioner. The part that I will miss the most is not knowing what is going on around the community. Right now there are so many things that are going to be so exciting for Davis County the next few years as they materialize and continue to move forward. Some things go pretty fast and some things don't. I'm still waiting to see the West Davis Corridor get built. The first question I was ever asked when I ran for city council was 'are you in favor of the Legacy Highway? (its name back then). It has been 17 years and we still don't have a record of decision where the actual alignment is going, but I think we will know more this coming year. I've always felt I was the lucky one to be able to be involved, especially here in the County. The employees have been so incredible. Sometimes you hear how lazy government employees are and your expectations are not too high as to what might take place when you're down here. I can tell you, in my feeling, I have never met so many people who know their jobs so well and see the public come in and get what they need and have it done right, that they were taken care of and had a good experience. That is what our job is, whichever it may be, our job is to help other people. It's a great life really. For me it has been outstanding. I have worked with some really fine department heads that try to solve the problems. If only you knew what they dealt with. It's a tough job. I relate it with auto mechanics. What happens in auto mechanics is that you become a half-way decent car mechanic and you think you can run your own shop. What you find out is that you knew a lot about cars, but you didn't know anything about managing people, advertising, bookkeeping, things that the other people already knew. That happens down here too. It has been great to be here with so many wonderful people who have become good friends. Working with the 3 commissioners that I have and these 2 lovely ladies (Shauna & Janet). If it wasn't for them, the 3 of us would look really bad. I think Randy will do a great job. Jim will obviously be the 'senior' guy now. Thank you all for being here today, for the recognition and for doing your jobs as well. Thanks again."

Mark Altom, Davis County Treasurer, requested under Section 59-2-1347 of Utah Code Annotated, to adjust taxes levied against certain real property located in Davis County and assessed by the Davis County Assessor. Specifically, it is in regards to a refund that was made by the Treasurer's Office based on incorrect information provided by a title company that is no longer in business. Mark recommends approval of the adjustment.

Neal Geddes explained statute UCA 59-2-1347 allows an interested person (tax payer) to submit a written request to the legislative body asking either for an adjustment or a deferral. It grants the legislative body broad discretion to either defer the taxes or, in this case, to adjust them to any sum less than the full amount where in the judgement of the legislative body the best human interest and interest of the state and the county are served. That is the standard. Another key portion, if there is a deferral, the amount deferred together with the accrued interest shall be due and payable when the property is sold or otherwise conveyed. If the Commission makes the determination to grant the adjustment, there is a requirement that the Commission cause the adjustment to be posted in the county where the property is located.

Commissioner Millburn indicated he has reviewed the request and has an understanding of some of the miscommunications and of this individual's circumstance.

Commissioner Millburn made a motion to adjust taxes levied to an amount of \$1.00 and then go forward with fulfilling the rest of the requirements under the Code. Commissioner Smith seconded the motion indicating that this is for the best human interest, the county and the state as set forth in the UCA. All voted aye.

Mark Altom thanked Commissioner Petroff Mark Altom wanted to publically thank Commissioner Petroff for his goodness. "You have been a dear friend and I was fortunate to be here today to see you honored. You are a good man and you have been the liaison between the Commission and the Treasurer's Office.
