



**PARK CITY COUNCIL MEETING MINUTES
445 MARSAC AVENUE
PARK CITY, SUMMIT COUNTY, UTAH 84060**

June 29, 2017

The Council of Park City, Summit County, Utah, met in open meeting on June 29, 2017, at 1:30 p.m. in the City Council Chambers.

WORK SESSION

Special Event Advisory Committee (SEAC) Interviews:

Mayor Thomas announced that the Canvass for the Primary Election to be held August 15th would need to be held August 22-29. After the election results were ratified, Council would meet with a consultant that was helping the Planning Department revamp the Historic District Grant program. It was decided to hold a special meeting for these purposes on Tuesday, August 29, at 9:30 a.m.

Mayor Thomas, Council and Jenny Diersen interviewed four applicants for the Special Events Advisory Committee: Deanna Rhodes, Joseph "Jesse" Santaularia, Peter O'Doherty and Devery Karz. The applicants were informed that a decision would be made in a few weeks.

Council Member Beerman moved to close the meeting to discuss property, personnel and litigation at 2:40 p.m. Council Member Gerber seconded the motion. Voting Aye: Council Members Beerman, Gerber, Matsumoto, and Worel. Council Member Henney was excused.

CLOSED SESSION

Council Member Gerber moved to adjourn from Closed Meeting at 4:30 p.m. Council Member Worel seconded the motion. Voting Aye: Council Members Beerman, Gerber, Matsumoto, and Worel. Council Member Henney was excused.

WORK SESSION

Council Questions and Comments:

Council Member Gerber indicated the Bonanza Flat celebration was great. She attended the Historic Park City Alliance (HPCA) meeting and noted they discussed parking and the new chain store ordinances. She also attended the Ski Utah meetings, the McPolin Barn structure upgrade grand opening, and Coffee with Council.

Council Member Beerman indicated he attended the Utah League of Cities and Towns (ULCT) Legislative Policy and Board meeting, noting there was discussion about states taking away municipal rights. He attended the electric bus ribbon cutting ceremony and the McPolin Barn event. He liked the Water Department's newsletter and thanked Michelle DeHaan. He also thanked Parking staff for helping return a dog to its owner. He attended the Prospector Business Alliance meeting, and indicated there were bid overruns on the sidewalk project. He attended the Planning Commission meeting where commissioners gave feedback on making exceptions for City projects. Erickson confirmed no exceptions were made for the 1450/1460 housing project. Council Member Beerman stated he would recuse himself from the Brew Pub and Streets items, and noted he felt residential traffic for events needed to be addressed.

Council Member Worel attended the Library Board meeting, the electric bus launch, the Transportation and Taxi group meeting, the Promontory Beach House ribbon cutting, the Skull Candy grand opening, and the Inaugural Pig Roast for the Children's Justice Center. She also indicated the Peoples Health Clinic had a Walk and Wine event for women's health, and some attendees wondered when staff would address a dog free area at Round Valley.

Council Member Matsumoto attended the electric bus event, the Bonanza Flat celebration, and the Sewer Board meeting. At the Special Event Advisory Committee (SEAC) meeting, it was decided to have community input on the impact neighborhoods had as a result of having events. She attended the Historic Home tour and announced she had a new grandson.

Mayor Thomas indicated Thomas Peek Sr. passed away this week.

Main Street Plaza Project: Review Plaza Goals and Project Design:

Jonathan Weidenhamer, Economic Development Manager, David Brems and Clio Reynar, GSBS Architects, and Matt Twombly, Senior Project Manager, presented this item. Weidenhamer stated the budget for this project was \$7 million, but the current estimate was \$8.3 million, and noted construction costs continued to rise. He reviewed the direction that Council had given staff and stated the plaza would come within 17% of being net-zero. He recommended not changing the design at this point. Council Member Matsumoto was in favor of keeping the road a one way street and thought signage and enforcement would help when there were big events. She was also supportive of the asphalt paving.

Council Member Worel thought this was a road and stated now it was referred to as a driveway. She stated the staff report also noted the traffic study wouldn't be complete until August, and asked what the remainder of the study was looking at. Matt Cassel, City Engineer, stated the traffic study would determine how the plaza would affect traffic movement on Hillside and the surrounding area. He stated as part of the plaza, there would be solutions that would be built to solve traffic problems. Council Member Gerber

asked if the road was part of the solution. Cassel stated the road would determine how the plaza would be used, be it wouldn't add to or hurt Hillside, but the road would be used to expand or contract the plaza. Mayor Thomas favored having the road remain a one-way street.

Council Member Gerber asked if the road needed to be there or could the City have a pedestrian walkway because this would change the way the City looked at the events held there. Reynar stated the driveway would need to be developed no matter what so there would not be a cost savings if it was eliminated.

Council Member Worel asked if the road would help with traffic circulation. Knotts stated the driveway might be a flex street in the future, but it did not solve traffic issues today. Council Members Worel, Gerber and Matsumoto agreed to keep the driveway/flex street, with the request to continue with the traffic study.

With regard to keeping the project under budget, Council Member Worel asked how much the budget would be cut if the water feature was removed and how much closer would the project be to the net zero goal. Council Member Matsumoto was in favor of keeping the water feature. Reynar stated cutting the water feature out of the project would reduce the cost by approximately \$120,000. Council Member Gerber was in favor of proceeding with the project at the \$8.3 million amended budget. Council Member Matsumoto and Mayor Thomas agreed to the higher budget as well. With regard to the net zero goal, Cartin stated there was a 20% contingency. There were many unknowns to the energy use, but solar panels would be on every flat surface and efforts to reduce energy would continue.

Mayor Thomas opened the meeting for public input.

Greg Schirf, owner of Wasatch Brew Pub, stated he was excited about the project. He noted having a pedestrian walkway next to his deck would be preferable to a street. He also noted the extra million to construct the project would be paid back in additional sales tax.

Susan Meyer, owner of Meyer Gallery, indicated she was excited for this project. She was concerned about pedestrian safety on Swede Alley. She also thought Hillside and Marsac were never pedestrian friendly.

Monty Coates, business owner on Main Street, thought this was a great project. He agreed with the comments on having a one-way road. He also stated the water feature was very attractive to people coming to the plaza.

Clive Bush thought the traffic study was brought in too late for this process. He also thought the preliminary report was biased. He stated the Trolley was not reliable public transportation as reported in the report and should not continue. He indicated the Main

Street Alliance hoped this would be a place to program events, which would create more residential pollution, as noise traveled uphill. He thought there were solutions, but the scope should be expanded.

Peter Marth stated he was pleased that the Council listened to the residents and at how the design was made with input from the residents. He didn't want a road going past his dining deck. He also expressed concern with the increased traffic on Hillside, and suggested redesigning Swede Alley to relieve the traffic on Hillside.

Doug Stephens stated interaction at the south end of the plaza concerned him because of how it affected Main Street. He asked if the intersection from Upper Main Street to Swede Alley had a sufficiently conducive turn for the trolley or food service trucks. He suggested a new route for the trolley.

Thea Leonard, Treasure Mountain Inn, disclosed she had an association with Council Member Beerman. She stated the traffic calming component was lost because the pavers were eliminated. These pavers would create the perspective that the road was ending and the motorist was moving into a pedestrian zone. She indicated this plaza would not be just for visitors, but would also be a respite for residents. She thought moving away from the pavers was short-sighted. A tax increase was self-imposed to have this plaza so it shouldn't be short-changed.

Carole Fontana supported everything Clive Bush related. She said this project began as a gathering place for people in the neighborhood and now it was being programmed with events. If it was over programmed, she would be forced to leave the neighborhood.

Mayor Thomas closed the public input portion of the meeting.

II. COMMUNICATIONS AND DISCLOSURES FROM COUNCIL AND STAFF

Staff Communications Reports:

- **Evaluation of Potential Incentive Program to Utilize Accessory Apartments for Affordable Housing Program:**

Council Member Gerber asked about the deed restricted accessory apartments. Anne Laurent, Community Development Manager, clarified this program would be for private homeowners who wanted to build accessory apartments, and the City would deed restrict them. Council Member Beerman asked staff to explore public outreach to see if the residents supported accessory apartments and also giving fee waivers for accessory apartments, and maybe having a shorter deed restriction so it wouldn't encumber the house for as long. Council Member Matsumoto stated that many areas in town allowed the accessory apartments, but it was an HOA that requested the City regulate accessory apartments. Harrington stated staff would continue to work on this issue, but he recommended that priority be placed on the projects at hand. When staff began to work on expanding the accessory apartment concept, they should work on it neighborhood by neighborhood to determine what CCRs allowed and what neighbors would tolerate as far as build out. Council Member Matsumoto stated a resident in the Park Meadows subdivision wanted accessory apartments, but the City required that it be attached to the house.

Bruce Erickson stated the concern was that there would be multiple rooms being rented to multiple people within one home, and each occupant having a car. A single family home was difficult to define, which made apartments in single family homes hard to handle. Laurent stated from a housing perspective, this issue would continue to be monitored.

Mayor Thomas opened the public input portion of the meeting for those who wished to address the Council on items not listed on the agenda.

Mike Sweeney stated he was a member of the HPCA Trash Committee. He indicated mobile recycling on Main Street was a problem. The committee found a location for the trash, but it was looking for a location to house two trailers and three pickup trucks. He asked if staff could work with HPCA on this issue.

Mayor Thomas closed the public input portion of the meeting.

VI. OLD BUSINESS

1. Request to Authorize the City Manager to Execute Professional Service Agreement, in a Form Approved by the City Attorney, with Downtowner, Inc. to Provide All Electric App Based On-Demand Neighborhood Transit Service in an Amount Not to Exceed \$358,727:

Alfred Knotts and Blake Foncesbeck, Transportation Planning, presented this item. Knotts reviewed all the projects that had been implemented or were being implemented as part of the Comprehensive Transportation Plan. He indicated that the micro-transit part of the plan began to be discussed in the fall of 2016. The terms of the RFP were to run within set boundaries, getting passengers to the main bus lines. Four bids were received and more than one bid offered the Tesla car in order to conform to the requirements listed in the RFP. The boundaries began to expand to service outlying areas, which resulted in pushback from the taxi companies. Micro-transit areas in the County were defined as well.

Knotts indicated it was expensive to run a transit system, and noted the service area could be expanded with the cost savings of using micro-transit. He acknowledged that there could have been better communication to the community on this type of transit. Because of the break in communication, he recommended putting the RFP out to rebid.

Council Member Matsumoto asked if the new RFP would propose the same zones, because residents in Old Town were already close to bus stops. Knotts stated Transit was operating under the same model throughout all areas of the community, and he wanted to see if there could be more efficiencies within the system by reevaluating the needs of the different service areas.

Council Member Worel stated the staff report talked about things that would be monitored during the pilot program, and asked if there would be a goal to determine if it was successful. Knotts stated the industry goal was increasing ridership by five percent.

Mayor Thomas opened the meeting for public input.

Marianne Soreno stated Jesse Shetler couldn't attend so she read his prepared statement. Shetler's businesses relied on transportation companies. He did not believe the City should provide this service, but it should support the taxi and shuttle companies. Soreno agreed with Shetler's statement.

Chris Judd stated he had a Tesla and drove for Uber and Lyft. This pilot program would hurt his business. He was against this program and felt taxpayer money should not fund this vehicle.

Ruth Meintom indicated she was for micro-transit. She took the bus to Salt Lake City and also used the electric bus to Kimball Junction. Transit users had to plan to use public transportation. She felt Old Town needed a different type of service since there were elderly people that needed help getting to the Transit Center.

Adam Strachan stated the General Plan encouraged the community to use alternative modes of transportation. He hoped this pilot program would have a chance to run its course.

Jack Fenton stated he sent an email to the Council offering to give them a ride to the Transit Center and nobody took the opportunity. He didn't think the City needed micro transit.

Luci Sosnowski, cab driver, stated the mobility bus for seniors and disabled residents worked great. She felt the micro transit program competed with the taxi service, and indicated the bus service was very convenient in Old Town.

Jennifer Gardner stated she lived 1.25 miles from the nearest bus stop. She got an e-bike to reduce her vehicle use. She was conflicted about this program and thought the Tesla was a very small car. She loved public transportation and suggested the City use buses that were half the size, then the taxi companies wouldn't feel as threatened. She supposed the smaller cars saved money.

Thea Leonard thought this was a great program and a bold move by the City. She noted progress was not made by caving in to status quo.

Michael Falk thanked staff for the meeting held last week. He was still against the program and thought it would be a challenge to make it work. He suggested starting smaller and just servicing employees of Old Town and the ski resorts in order to get those cars out of town. He hoped that if it went forward, that the taxi companies could be part of it.

Jim Hosley stated there was some confusion with regard to this program. This was a different mode of public transportation, and there would be cost savings by not running 3-4 diesel powered buses.

Jennifer Gardner requested that the contract include that this service could not pick up guests from hotels.

Angela Moschetta explained there was a survey circulating in the community that was very leading and misleading and should be ignored. She indicated the opposition to the Downtowner did not respond to the RFP. There was also a claim that money would be given to a company outside the City, which she noted sometimes happened when there were qualified responders, although Downtowner would be hiring some local employees for this program. She thanked Knotts and Coulson for their efforts to improve the community. She felt the micro-transit was part of the solution and supported this pilot program. She asked Council to approve the Downtowner.

Luci Sosnowski said Downtowner was only in five cities and one city had dropped out, so there was no proven track record.

Steve Joyce stated he would use this service if it was implemented. He asked about point-to-point service versus getting a passenger to the bus stop, and indicated that should be considered. He also recommended defining goals for this amount of money being spent.

Sarah Berry stated if a six month trial would destroy the taxi industry, they had big concerns. She thought this program would help staff gain valuable information.

Kerri Allardyce, Hope Cars, appreciated the transportation meeting with the transportation industry. She felt a lot of headway had been made and there was now a better understanding. She was not opposed to micro-transit but was concerned about the drivers of the Downtowner operating outside the transit zones. She looked forward to finding multiple solutions to this issue.

Rob O'Brien, 649 Taxi, stated he was opposed to this program. He hoped that the City would let the taxis have an opportunity to help with this program.

Sam Rubin presented a PowerPoint with survey results from a survey that was found on Facebook. After the presentation, Mayor Thomas stated surveys could be crafted to sway the public, and this one was inaccurate from his perspective.

Mayor Thomas closed the public input portion of the meeting.

Council Member Matsumoto asked if Tesla was the only electric car that could be in Park City. Knotts stated it was the only one that could operate in the snow and terrain of the area and could also carry skis.

Council Member Worel appreciated the openness of Knotts in being willing to listen to the transportation companies. She was a proponent of micro-transit and felt it would save on energy costs. She indicated the transportation companies had come up with some apps that might provide the same kind of service that the RFP specified. She

requested the RFP be reopened for a shortened period of time and include measurable goals.

Council Member Beerman asked Knotts about the costs for Teslas. Knotts noted the vehicles would be leased. Council Member Beerman indicated the employees within the City would be serviced by a park and ride lot and bus from The Yard to Main Street. Fannesbeck confirmed and indicated the Downtowner could also be used to shuttle those employees in addition to the scheduled buses. Council Member Beerman asked about the goals for the pilot program. Knotts indicated parameters had been set and would be evaluated at the conclusion of the pilot program. Knotts also stated the numbers from Park City would be compared with other cities using this service. Knotts stated he hoped there would be a four percent increase in ridership system-wide.

Council Member Beerman commented that traffic and congestion was an area where an urgent solution was needed. He noted that from the public input received tonight, there were areas that could have been done differently. He felt the RFP should be put out for a rebid. He recommended that the door-to-door service be altered to utilize the transit stops more and to add more stops. He thought the service should be started earlier and ended earlier, and that staff should consider GEM cars. He thought the Teslas were the best choice, but thought whoever bid on the RFP should be mindful that the City preferred electric vehicles. He also favored extending the routes to include all the City, and hiring local drivers.

Harrington stated a motion could include a *less restrictive* "vehicle could be used if it did not sacrifice safety." Fannesbeck stated Transportation had scheduled future implementation dates for the outlying areas in the City. Mayor Thomas stated this service was just a six month test so the plan could be suspended. Council Member Worel asked how many more vehicles would be needed if the pilot program was expanded to encompass the entire City. Knotts stated an analysis would have to be performed to determine the number of additional cars needed.

Council Member Gerber felt this transportation option was focused on the residents and this was the best solution for getting the residents out of their cars on a daily basis. This would provide benefits to the seniors and parents with small children and teenagers. She used a Downtowner in Aspen, Colorado, and indicated the Tesla was the most efficient car for this community. She supported approving the contract with Downtowner today, and suggested the taxi companies could run a program simultaneously.

Council Member Beerman moved to reject all bids and direct staff to return with a revised scope and clarified milestones for a new RFP and elements that should include avoiding door-to-door service, adjusting the time of service to begin earlier and to end earlier, comparing and/or considering other vehicles that could be used for the pilot program, and point out reasons for the vehicle chosen, increasing scoring for local

hiring, and creating a proposal that would service residential areas such as deep Park Meadows and Thaynes Canyon. Council Member Worel seconded the motion.

1. Consideration to Approve Resolution 18-2017, a Resolution in Support of Local First Utah's Independents Week:

Mayor Thomas opened the public hearing. No comments were given. Mayor Thomas closed the public hearing.

Council Member Beerman moved to approve Resolution 18-2017, a resolution in support of Local First Utah's Independents Week. Council Member Gerber seconded the motion.

2. Consideration to Approve Resolution No. 19-2017, a Resolution Recognizing the Value of Federal Public Lands to Park City, Utah's Economy, Recreation and Quality of Life:

Mayor Thomas opened the public hearing.

Peter Gatch read a prepared statement supporting public lands. He indicated Charlie Sturgis, Amy Mills and others who had to leave the meeting concurred with this statement.

Mayor Thomas closed the public hearing.

Council Member Beerman indicated he was happy to see this resolution. The other members of Council agreed.

Council Member Beerman moved to approve Resolution No. 19-2017, a resolution recognizing the value of federal public lands to Park City, Utah's economy, recreation and quality of life. Council Member Gerber seconded the motion.

3. Consideration to Approve the 2017 Park City Kimball Arts Festival, a Level Three Special Event, and Approve the Estimated City Service Special Event Fee Reduction in the Amount of \$172,860.00 in Accordance with the City Services Agreement:

Jenny Diersen, Special Events Coordinator, and Dave March, Executive Director of Kimball Arts Center (KAC), presented this item. Diersen reviewed some changes to the supplemental plan. The Gala would be held July 13 and would be considered a Level One Event. The art festival would be held August 4-6. March stated 2017 would be a baseline year for their sustainability efforts and in 2018 they would set a goal to reduce waste by 15%. They would encourage vendors not to use plastic bags, and they would use recyclable products, reusable banners, etc.

Diersen indicated there would be a \$20 charge for parking on China Bridge during the event, but free parking would be at the resort lots and the school district. A bike valet would also be available at 7th Street. With regard to communications, there would be a door-to-door notice, the text alert system, and the information would be translated into Spanish.

Diersen stated the KAC would pay \$10,000 for City services and requested a fee waiver for the rest of the fees.

Mayor Thomas opened the public hearing. No comments were given. Mayor Thomas closed the public hearing.

Council Member Beerman requested that the festival ban plastic bags in 2018.

Council Member Worel moved to approve the 2017 Park City Kimball Arts Festival, a Level Three Special Event, and approve the estimated City service special event fee reduction in the amount of \$172,860.00 in accordance with the City Services Agreement. Council Member Beerman seconded the motion.

Council Member Matsumoto asked if this fee waiver was included in the \$200,000 threshold. Diersen indicated this was a contract and outside the \$200,000 fee waiver threshold.

4. Consideration to Approve Ordinance No. 2017-31, an Ordinance Amending Title 4, Licensing, Chapter 2, Business Licensing in General, Section 29 Vibrant Commercial Storefront in HCB and HRC, of the Municipal Code of Park City, Utah:

Jonathan Weidenhamer, Economic Development Manager, indicated that this ordinance would not allow businesses to get a temporary alcohol licenses if they didn't have a vibrant and active storefront throughout the year

Mayor Thomas opened the public hearing. No comments were given. Mayor Thomas closed the public hearing.

Council Member Worel indicated the language of the first sentence in 4-2-29, *"In order to be a Vibrant Commercial Storefront, a Storefront Property cannot meet four (4) or more of the seven (7) following conditions:"* could be written more clearly. Harrington proposed the following amendment, *"A Vibrant Commercial Storefront is a Storefront Property which cannot meet four (4) or more of the seven (7) following conditions:"*

Council Member Gerber moved to approve Ordinance No. 2017-31, an ordinance amending Title 4, Licensing, Chapter 2, Business Licensing in General, Section 29 Vibrant Commercial Storefront in HCB and HRC, of the Municipal Code of Park City, Utah, with the above mentioned amendments. Council Member Beerman seconded the motion.

5. Consideration to Approve a Coexistence Agreement with HIBL & SONS, LLC D.B.A. Park City Coffee Roasters ("PCCR") Which Enables PCCR to Proceed with Their Application to Register a Mark for "Park City Coffee Roaster":

Mark Harrington indicated this was the first trademark application since the Vail Trademark application was opposed by the City. He noted there was no risk of this trademark being misunderstood as referring to the City alone. Staff recommended approval.

Mayor Thomas opened the public hearing.

Rob Hibl stated he appreciated the time the City spent on this issue.

Mayor Thomas closed the public hearing.

Council Member Beerman moved to approve a Coexistence Agreement with HIBL & SONS, LLC D.B.A. Park City Coffee Roasters (“PCCR”) which enables PCCR to proceed with their application to register a mark for “Park City Coffee Roaster”. Council Member Matsumoto seconded the motion.



Figure 6-1: Canyons/Bear Hollow/Silver Springs Call a Bus Areas




Figure 6-10: Deep Park Meadows/Aspen Springs Call a Bus





Figure 6-9: Summit Park/Jeremy Ranch/Pinebrook Call a Bus

Additional Comments and Feedback...

Park City needs to focus on small businesses and employees, they need to address parking and not transportation. They are making it really hard for businesses to keep staff with forcing them on buses as it is not realistic.

Additional Comments and Feedback...

I also think this would be a great way to limit the number of Uber's during Sundance and other busy weeks. Traffic this year was insane. How about instead of spending money on cars to give people rides to bus stops spend the money on getting bus service to Summit Park. The closest bus stop for Summit Park is Jeremy Ranch which is about a 30-45 minute walk. Summit Park & Timberline are basically forgotten areas of Park City

Monumental waste of tax dollars. Clearly city staffers are utterly out of touch, don't care that they're spending other people's money 💰 on foolish projects. Hopefully City Council has more common sense.



Additional Comments and Feedback...

I can't believe this is even in question. This is a huge amount of money that could be allocated to making the current transportation system more accessible to everybody.

I don't feel like adding four vehicles to take people to bus stops will be helpful. It seems like it would make more sense to add more bus stops.

I think this is a terrible idea, the city is essentially eliminating jobs many of the cab drivers in town have been driving for 15 or more years. So the city is essentially putting them out of work. I am not happy about spending my tax dollars on this there are many other things we can spend it on like education for one.

I'm still befuddled as to why Silver Creek is a completely forgotten route on the bus line.. We are now going to Kamas, but Silver Creekers are SOL

- Responders would use “Local App” more than Uber/Lft – 84060 (70%), 84098 (65%), Total (67%)
- A “Local App” would mean less demand for Uber/Lyft... meaning LESS CARS ON THE ROAD!
- If “Local App” gave back to Non Profit... above increases – 84060 (78%), 84098 (77%), Total (77%)
- 73% of Responders DO NOT WANT Park City to spend \$360,000 on the 6 month pilot!!!

RE: Brew Pub Plaza Purpose and Design Discussion

Dear City Council,

The HPCA feels that our historic downtown business district is a vital cog in our economic engine, and in achieving the sort of adaptive reuse of historic structures that preserves a vital part of our community character. It is a district that serves many purposes from retail shopping and commercial services, to eating and entertainment, to host for some of our most iconic community events. Viewing the Brew Pub Plaza through this lens our membership is concerned about the evolution of the Brew Pub Plaza design and attempts to restrict its' future use. Our concern is that the changes already made and those being discussed including the creation of a bi-directional, full time access road along the northern boundary run the risk of turning what was intended to be a top of Main Street attraction into a grade separated pocket park that does little to complete the street or attract patrons to businesses at the south end of the commercial business district. The specific design and use issues can be summarized as follows:

1. A full time access of great enough width / radius for transit and service vehicles to use on a daily basis creates both a physical and visual barrier to the plaza for the very pedestrians we were hoping to attract to the plaza. It could create the same sort of fear for your safety crossing as the one that currently occurs peering around the corner of Java Cow while navigating across 4th street. The added difficulty in this case is that in addition to the street crossing, the pedestrian experience of the plaza also begins with a grade separation and flight of stairs. So instead of inviting people into a top of Main Street attraction we are headed towards creating a feeling of a place you are not supposed to go and that you may as well turn around at that point.
2. The more space taken for road way width the less is left for programming, an amenity space, and replacement of the existing parking as intended. The direction to provide a full width street along the north end of the plaza will continue to squeeze the available space left in the design to make the plaza and the associated substructure functional for what the HPCA feels were the carefully negotiated primary purposes of the project. This when the design and value engineering evolution to this point has already facilitated a shift in functionality from a design more conducive to serving as a programmed amenity space to one that seems primarily destined for use as a passive park space.
3. Preserving enough space for the new Brew Pub Plaza to host temporary events or portions of events and flex in size to meet temporary needs is a vitally important component to having Main Street businesses support for the overall project. One of the primary drivers that garnered widespread support among HPCA members was the ability to consolidate the activity from certain temporary events into a space designed for that purpose rather than having those activities spread up and down Main Street.
4. The noise, pollution, and disruption from a full time access road would also create immediately adjacent negative impacts for some of our member businesses like the Wasatch Brew Pub who is in the process of making a major investment in private infrastructure improvements to compliment the previously described plaza design.

The HPCA views any option for the plaza design that would include a full time access street along the northern boundary as having nearly fatal flaws. Having said this, the HPCA does understand the need to provide alternate routes for vehicular traffic that don't rely upon the use of residential streets, especially when programmed activity in the plaza precludes use of the Suede Alley - Main Street connection. For this reason the HPCA is supportive of having an intermittent use, smaller width, single direction access between Suede and Main at the north end of the project. However our members feel that the design, grading, and other design consideration for this access should seek to make it feel a part of the plaza design and not an additional barrier to pedestrian access up the street. The implementation plans and management of how this access point is utilized should also put pedestrian crossing safety and ease of access first.

The HPCA is sensitive to the impacts immediately adjacent residential neighborhoods feel from large scale events utilizing public infrastructure in the historic commercial district and in fact are also negatively impacted by some of the same factors such as the abundance of transportation service vehicles. The HPCA for this reason supports giving the transportation, transit, and event staff the resources they need to better manage these temporary events and peak period seasonal traffic with the goal of limiting residential impacts. We have also broadly supported the parking and transportation initiatives currently under development to lessen some of these impacts and provide better alternatives for patrons of our historic commercial district.

However, we don't believe that the best way to address broad community concern over traffic impacts is to view each and every project through the lens of maximizing passive enjoyment and compromise between residential and commercial use. There should be room for projects wholly contained within the HCB and funded by taxes and assessments collected largely within district boundaries to create an amenity and set of solutions to events that work for our member businesses. A significant portion of these same funding sources will be utilized or have been committed to purchase open space thereby creating places for passive enjoyment, increased community scale sustainability, and reducing future trip generation. So, it seems appropriate that funding utilized for projects within the district be focused on creating an amenity to the district and reducing impacts to contributing members. We look forward to continued cooperation and dialogue in helping to keep Old Town Park City a vibrant place to do business, to host the world, and a great place to live.
