OPENING:

The regular meeting of the Five County Homeless Coordinating Council was called to order at 11:33 a.m. on August 17, 2011 in St. George, Utah by Jane Lewis (neither the chairperson or co-chairperson were in attendance and Ms. Lewis asked Council is they wanted her to proceed). Those present to state his or her name and place of employment. Co-chair Ray Sim arrived and the meeting was turned over the co-chair.

A. APPROVAL OF AGENDA

Britton Lund made a motion to approve the minutes. Frank Yoder seconded the motion.

B. APPROVAL OF MINUTES

The minutes of the previous meeting were not approved as distributed, as a quorum was not present.

C. AGENDA ITEMS

HPRP/TANF Information

Dixie Care and Share: No representative was present. Iron County Care & Share: HPRP money is going to expire in January 2012 at Iron County Care and Share.

Homeless-Housing Subcommittee

Housing: Frank Yoder, Chairperson for Subcommittee discussed a few housing project Resource & Reentry and the committee has viewed. R&R is looking at a single-room occupancy (SRO) in Hurricane. The SRO would house about 15 individuals with employment support. The committee as is looked at a hotel in St. George with 16 units. Frank stated he has begun to look into ways of financing a purchase. Council member received a sheet with an explanation of Supportive Housing to demonstrate reasons why this model should be considered as an alternative to rental assistance.

Homeless Pamphlet: The subcommittee distributed a rough draft pamphlet for providers and police officers to handout to homeless individuals. Community Action Partnership hired an intern to assist with putting together a pamphlet. Council members were asked to make notes on the pamphlet with their suggestions/corrections or email corrections to Jane Lewis.

Washington County Homeless Summit Bring Homeless/Housing Question for Candidates

During the June meeting, there was a discussion regarding a local homeless summit and Council members were asked to bring questions for candidates running for St. George City Council. Attendees were encouraged to attend the September 6th Candidate Forum at the St. George Library with their questions regarding housing and homeless issues.

Housing Authorities Expansion

Keisha Greenwell, St. George Housing Authority and Heidi Miller, Cedar City Housing Authority presented information regarding housing options and Section 8 Vouchers. St. George has 244 Section 8 Voucher and Cedar City 139 Vouchers. When new vouchers come available the local housing authorities are applying for them, however, it is a "lottery system". The housing authorities do not anticipate any other Section VIII vouchers becoming available. The waiting list is an average of 1-3 years, because the vouchers only become available when others leave the program. St George Housing Authority has 30 units for senior housing (over 62) and individuals pay 30% of their wages towards this housing. The St. George Housing Authority receives about \$1,000.00 per month for emergency funding that may cover part of the family's move-in costs and first month's rent, however, the family will need evidence they can cover the following months. The housing authorities provided an explanation of Section 42, Tax Credit Apartment Complexes. A list of housing developments was handed out, however, there may be several subsidized units in St. George, many of these are not "affordable" for those families & individuals making minimum wage. St. George Housing Authority has 10 of their vouchers that can be used towards a project-based development. There was a discussion about the cost of background checks (BCI). It was mentioned that a few apartment complexes are charging high fees for BCIs.

Ark of Little Cottonwood, Dammeron Valley New Business

Jeremy Boberg, of ARK made a brief presentation of their new program in Washington County. The program is a multidisciplinary center and they contract with the Veteran's Administration to serve homeless veterans. Council members were encouraged to refer veterans to the program.

Employment and Job Creation in the Area

Lori Economy from Department of Workforce Services (DWS) presented on current employment and job creation in Southern Utah.

New Business:

Five County Association of Governments has received notification for the Emergency Food and Shelter Program funding. The local jurisdiction's award is based upon the jurisdiction's total number of unemployed, between March 2010 and February 2011, and compared to the total number of unemployed in <u>all</u> qualifying jurisdictions. Iron County was the only local jurisdiction funded. Previously Washington County had received funding for 30 families to cover emergency shelter for one month if they can provide evidence they could cover the next month.

Frank Yoder, Resource & Reentry Director, presented some potential job opportunities that are collaborating with other agencies. A temporary employment service is being set up to work with the business that R&R is coordinating with for the job openings. Frank showed a brief DVD of his program Resource and Referral. Reimbursement

ADJOURNMENT:

Frank Yoder made a motion to adjourn, which was seconded by Ray Sim. Meeting was adjourned at 1:00 p.m.
