RE: TEMPORARY SIGN REQUEST

The Zion Canyon Arts and Humanities Council is looking forward to bringing the 28 th annual Zion Canyon Arts and Crafts Fair to the Rockville Community Center! This event will be held Thanksgiving Weekend, on November 24 & 25 from 10 am to 5 pm.

Temporary signage in the form of vinyl banners would help to direct traffic to the correct location. We seek to place two 2' x 3' banners on either side of town: on the Ballard property on the east side and on the Brantley property on the west side of town.

We have two 3' x 6' vinyl banners to place at the community center, either back to back or in a small triangle for better visibility. All four of these banners would be secured by t-posts and zip ties. They would be up for approximately one week to 10 days. They will not be illuminated.

We also have two 3'x3' vinyl banners to attach by bungee cords to vehicles. By placing them on the street with a few orange cones to ensure visibility, it will be hard to miss the community center. These would only be up during the event hours, and they will not be illuminated.
