a. Canvass of the Election Returns

After the meeting had been duly called to order the Business Administrator presented to the Board a Certificate of Compliance with Open Meeting Law with respect to this November 21, 2017 meeting.

It was then moved by Board member Don E. Belnap, seconded by Board member Susan Richards, and carried unanimously that the Board sit as a Board of Canvassers for the purpose of canvassing the returns of the special bond election held in the District on November 7, 2017.

The Board thereupon made a proper canvass of the election returns of said special election in accordance with Sections 11-14-207, 20A-4-301(3), 20A-4-302 and 20A-4-303, Utah Code Annotated 1953, as amended, and at conclusion of the canvass made the following official findings:

#### **PROPOSITION**

Shall the Board of Education (the "Board") of Ogden City School District, Utah (the "District"), be authorized to issue General Obligation Bonds in an amount not to exceed One Hundred Six Million Five Hundred Thousand Dollars (\$106,500,000) (the "Bonds") for the purpose of paying all or a portion of the costs to purchase school sites, purchase or construct buildings, furnish schools or improve existing school property; said Bonds to be due and payable in not to exceed twenty-six (26) years from the date of issuance of the Bonds?

<u>Property Tax Cost of Bonds</u>: If the Bonds are issued as planned, (and without regard to the existing taxes currently paid for existing bonds that will reduce over time), an annual property tax to pay debt service on the Bonds will be required over a period of twenty (20) years in the estimated amount of \$158.07 per year on a \$167,000 residence (primary) and in the estimated amount of \$287.41 per year on a business property (and secondary residence) having the same value.

The District has other outstanding bonds for which a tax decrease would occur upon the retirement of such bonds which may not occur if the proposed Bonds are issued. However, these outstanding bonds reduce over time such that the incremental property tax burden due to the issuance of the proposed Bonds on residences and businesses within the District is expected to have no cumulative increase from current annual levels.

The foregoing information is only an estimate and is not a limit on the amount of taxes that the Board may be required to levy in order to pay debt service on the Bonds. The Board is obligated to levy taxes to the extent provided by law in order to pay the Bonds. The amounts are based on various assumptions and estimates, including estimated debt service on the Bonds and taxable values of property in the District.
