Dr. Terry reviewed the recommendation from administrators to hire a social worker or school psychologist.

Mr. Ure suggested the District consider exploring possibilities for the county to pay for the SRO, so the District can use the funds for additional social work or citizenship program support. Dr. Terry committed to visiting with the Sheriff's office.

The District is exploring the possibility of adding a bus route to encourage students to enroll at Minersville school. So far the number of students who have expressed an interest is very small. Dr. Terry believes a

boundary change is a necessary requirement before more students will attend Minersville. The group discussed the possibility of extending the new bus route for families east of the highway. The group discussed the possibility of not offering the new bus route. The group also discussed the impact of a boundary changes. There group consensus was to not offer a new bus route given the small interest.

Dr. Terry summarized the earthquake drill. There were over 100 employees involved with several local agencies. The drill produced information that will help improve preparation for the future. Several explained their experience with the drill and appreciation for everyone who participated in the drill.

**Business** Mr. Burke summarized the negotiations which the County and **Administrator:** contracted attorney have had regarding the property tax (1:50 pm) settlement with CS Mining. The settlement has resulted in approximately \$1.1 million in a one-time payment to the District. The District expects to receive this payment soon.
