Re: Request for Change in Services - Master Interlocal Agreement

Dear Mr. Barker,

The White City Metro Township Council (hereafter "White City"), on June 7, 2018, adopted Resolution 18-06-03 instructing me to provide a letter to the Greater Salt Lake Municipal Services District (hereafter "MSD") to start the official process to modify the level of services the MSD receives from Salt Lake County pursuant to the Master Interlocal Agreement between the MSD, Salt Lake County and Metro Townships (hereafter "Agreement"). See copy of Resolution attached.

Pursuant to Sections 1.8 and 2.4 of the Agreement, the MSD can request a change in level of services upon 90 days' notice. In addition, the Agreement expressly provides that prior to the end of each calendar year "the parties [shall] acknowledge in writing . . . which services will continue to be provided by the County for an additional year and which services will be discontinued upon expiration of the then current calendar year." Agreement §1.2.

White City believes the following services should no longer be provided by Salt Lake County after the conclusion of this year: (a) Planning and Development Services, (b) Public Works Engineering for projects within the Metro Townships, and (c) Community Outreach. Instead, White City would like to see the foregoing services be provided directly by the MSD itself. While not expressly noted in the Resolution, White City has been on record that it would hope that such services would continue to be provided by current County employees, which employees would transition to MSD employment.

Thank you for your consideration of this matter. White City asks that it be placed on the MSD Boards agenda(s) as needed to comply with the Agreement.

As always, thank you for all you do for the MSD, White City and the other Metro Townships.

A RESOLUTION AUTHORIZING THE OFFERING OF A LETTER TO THE GREATER SALT LAKE MUNICIPAL SERVICES DISTRICT (MSD) SEEKING A MODIFICATION OF THE MASTER INTERLOCAL AGREEMENT BETWEEN THE MSD, THE METRO TOWNSHIPS, AND SALT LAKE COUNTY

RECITALS

- A. The White City Metro Township ("White City") is a municipality pursuant to Utah Code Annotated ("UCA") §§ 10-2a-401 *et seq.*
- B. The White City Metro Township Council (the "Council") is the municipal legislative body of White City pursuant to UCA § 10-3b-501.
- C. The Greater Salt Lake Municipal Services District (the "MSD") is a Local District pursuant to UCA §§ 17B-2a-1101 *et al.*
- D. Salt Lake County (the "County") is a county pursuant to Utah Code Ann. Title 17 Counties, and is the contracted service provider of certain municipal-type service via the MSD.
- E. White City receives services from Salt Lake County, through the MSD, pursuant to a Master Interlocal Agreement (the "Agreement"), which is subject to amendment to insure the services being provided are of a satisfactory quality and consistent with the needs of the Council and the Community. See, eg., Article II, section 2.4.
- F. White City feels the offered of a letter proposing certain amendments for consideration by the MSD will greatly benefit White City and the MSD and improves effectiveness, efficiency, overall quality, and better control costs of services.

RESOLUTION

NOW THEREFORE BE IT RESOLVED, the White City Metro Township Council approves the offering of a letter to the MSD seeking a modification of the Master Interlocal Agreement between the MSD, the Metro Townships, and Salt Lake County, and

BE IT FURTHER RESOLVED, the letter be composed by Council Staff to present to the MSD at its Planning Meeting to be held on Friday June 8, 2018 at 9:00am as a possible agenda item for their upcoming meeting on June 13, 2018.
