DISCUSSION AND POSSIBLE ACTION ON LOAN TO HEBER VALLEY RAILROAD.

Mike Davis Wasatch County Manager addressed the Wasatch County Council regarding a loan to Heber Valley Railroad. Tom Jacobsen one of the Directors for Heber Valley Railroad advised there are 19 pieces of equipment to be purchased in British Columbia, these cars are essential to Heber Valley Railroad. There will be 3 payments, the first payment is due now of \$750,000 Heber Valley Railroad has put down \$50,000 2nd payment can be up to \$750,000 for moving equipment, and the 3rd payment is in two years.
