MATTIE THORSTED- SUSPENSION SCOTT STATES MS THORSTED PERMIT WAS SUSPENDED BASED ON THE SUSPISION THAT SHE WAS A DANGER TO HER SELF OR OTHER PREVIOUS BOARD UPHELD THE STATE THAT THORSTED PROVIDE A LETTER FROM HER STATED SHE WAS IN GOOD HEALTH AND NO LONGER A THREAT TO HER SELF OR OTHERS. THE LETTER WAS APPROVED ON THIS DAY APRIL THIRD PAUL MOTIONS TO GIVE PERMIT TO MS THORSTED CHRIS SECONDS ALL IN FAVOR

ALLEN THOMASON- REVOCATION MINDY STATES THAT MR THOMASON PERMIT WAS REVOKED BASED ON A MISDEMEANOR CONVICTION INVOLVING IMPAIRED DRIVING THROUGH THE STATE OF UTAH CHRIS MOTIONS TO UPHOLD THE STATE PAUL SECONDS ALL IN FAVOR UNANIMOUS UPHELD

ISAAC PEREZ- DENIAL HESLOP STATES THAT MR PEREZ PERMIT WAS DENIED BASED ON A AUGUST FIRST 2016 CONVICTION INVOLVING POSSESSION OF DRUG PARAPHERNALIA A CLASS B MISDEMEANOR THROUGH THE STATE OF UTAH MR PEREZ STATES THAT HE WOULD LIKE HIS PERMIT BACK FOR HIS OWN SELF PROTECTION WHILE HE IS GOING TO BECOME A REAL ESTATE AGENT. PAUL MOTIONS TO UPHOLD THE STATE AND MODIFY ELIGIBILITY TO 08-2-2020 CHRIS SECONDS ALL IN FAVOR UNANIMOUS UPHELD

JOHN HONEYCUTT-REVOCATION – MINDY STATES THAT MR HONEYCUTTS PERMIT WAS REVOKED BASED ON A MISDEMEANOR CONVICTION INVOLVING GAMBLING PROMOTION THROUGH THE STATE OF UTAH. MR HONEYCUTT STATED THAT HE PLEAD GUILTY TO THE CHARGE PAUL MOTIONS TO UPHOLD THE STATE BUT MODIFY THE DATE FOR ELGIBILITY TO 07/30/2020 CHRIS SECONDS THE UPHELD MOTION ALL IN FAVOR UNANIMOUS UPHELD

MICHAEL KIDMAN KRAMBULE- REVOKED THIS WAS HEARD IN PREVIOUS BOARD WE REQUESTION MORE INFORMATION ON REDUCTION OF HIS 402 THE DOCUMENTS MR KRAMBULE PROVIDED STILL DID NOT SPECIFY A CERTAIN

SEVERITY THEREFORE THE BOARD MAKE A DECISION TO TABLE PAUL MOTIONS TO TABLE CHRIS SECONDS ALL IN FAVOR

THOMAS MULLALY-DENIED- MINDY STATES THAT THE PERMIT WAS DENIED BASED ON A THEFT CHARGE THROUGH THE STATE OF UTAH IN 2016 CASE WAS LEFT OPEN DUE TO LACK OF FUNDS BUT STILL PAYING ON CASE WAS CLOSED AND COMPLETED ON 10/06/2017 CHRIS MOTIONS TO UPHOLD THE STATE AND MODIFY ELIGIBILITY 02/11/2020 PAUL SECONDS ALL IN FAVOR UNANIMOUS UPHELD

ANTHONY COMBS- REVOKED HESLOP STATES THAT MR COMBS PERMIT WAS REVOKED BASED ON A MISDEMEANOR CONVICTION (PIA) INVOLVING LEWDNESS THROUGH THE STATE OF UTAH. CHRIS MOTIONSTO UPHOLD STATE PAUL SECONDS ALL IN FAVOR UNANIMOUS UPHELD

CLAYTON EDWARDS-REVOCATION-MINDY STATES THAT HIS PERMIT WAS REVOKED BASED ON A 2003 FELONY CONVICTION INVOLVING AGGRAVATED ASSAULT THROUGH THE STATE OF KANSAS. RECORDS INDICATE CHARGE HAS BEEN EXPUNGED BUT THIS IS NOT A TRUE EXPUNGEMENT OF NICS PURPOSES. CHRIS MOTIONS TO UPHOLD STATE PAUL SECONDS ALL IN FAVOR UNANIMOUS UPHELD

ALEJANDRO RAMIREZ-DENIAL HESLOP STATES THAT THE PERMIT IS DENIED BASED ON A MARCH 30 2016 MISDEMEANOR CONVICTION INVOLVING LIQOUR POSSESSION BY A MINOR THROUGH THE STATE OF UTAH ELIGIBLE 04/1/2020 CHRIS MOTIONS TO UPHOLD THE STATE BUT MODIFY THE ELIGIBILITY DATE TO TIME TO 10/1/2019 WE HAVE A SUB MOTION FROM PAUL, PAUL MOTIONS TO UPHOLD STATE AND ALLOW PERMIT TO BE ISSUED AS OF TODAY CHRIS SECONDS ALL IN FAVOR

KRISTINE BURNINGHAM- DENIED-ABSENTIA- HESLOP STATES THAT MS BURNINGHAMS PERMIT WAS DENIED BASED ON A MISDEMEANOR CONVICTION INVOLVING ALCOHOL RELATED RECKLESS DRIVING THROUGH THE STATE OF UTAH CHRIS MOTIONS TO UPHOLD THE STATE PAUL SECONDS ALL IN FAVOR UNANIMOUS UPHELD

AMOS BRINKLEY- DENIED-ABSENTIA- HESLOP STATES THAT THE PERMIT WAS DENIED BASED ON A CRIMINAL TRESSPASS INVOLVING DV THROUGH THE STATE OF WASHINGTON CHRIS MOTIONS TO UPHOLD THE STATE IN THE DENIAL PAUL SECONDS ALL IN FAVOR UNANIMOUS UPHELD
