BACKGROUND DISCUSSION:

City staff advertised for stock contractor services for the 2019 Western Stampede PRCA Rodeo through an RFP, the proposals for which were due Oct. 2, 2018. The only proposal received was submitted by Mike Cervi Championship Rodeo, LLC.

Cervi Rodeo is sanctioned by and a top ranked stock contractor within the Professional Rodeo Cowboys Association. Cervi Rodeo was the West Jordan selected bidder in 2013 which was renewed for 2014 and 2015. They were the selected bidder again for the 2016 Western Stampede, the contract for which was renewed for the 2017 and 2018 rodeos.

The currently proposed agreement is for a one-year contract with the possibility of five additional years.

AGREEMENT FOR SERVICES

THIS AGREEMENT FOR SERVICES (the "Agreement") is made this April , 2019 by and between the City of West Jordan, a municip	1st day of

(hereinaster referred to as "City"), and Cervi Championship Rodeo, L.L.C. a Co	
liability company (hereinafter referred to as "'Contractor").	

WHEREAS, the City desires to obtain services from Contractor, and Contractor desires to provide these services to City.

NOW THEREFORE, City and Contractor agree as follows:

1. <u>Retention as Contractor.</u> City hereby retains Contractor, and Contractor hereby accepts such engagement, to perform the services described in Paragraph 2 herein. Contractor warrants it has the qualifications, experience and facilities to properly perform these services.

Description of Services.

Contractor shall stage and produce a PRCA approved rodeo for a total of three (3) days to be held on July 4, 5 and 6, 2019 (the "Event"), and shall perform the following services, at Contractor's sole expense:

- a. Arena Director/Chute Boss
- b. Flank Man/Livestock Superintendent
- c. Two (2) Pick-up Men
- Equipment (flank straps/halters) and Barrier for Rodeo Events
- e. Rodeo Secretary (who will provide a day sheet to City by 10:00 a.m. each day)
- f. Announcer
- g. Two (2) Timers
- h. Two (2) Bullfighters
- i. Clown & Barrelman with Acts
- j. Sound Operator
- k. Music System
- Chute Labor (will also work directly with qualified City volunteers)
- m. Hay/Grain and Feed Crew for all Rodeo Livestock
- n. Transportation for all Rodeo Livestock
- o. Production of Grand Entry and Opening Ceremonics
- p. Consultation and professional services throughout the calendar year.
- q. Top Stock for the following:
 - Bareback Riding
 - Saddle Bronc Riding
 - Tic Down Roping
 - Steer Wrestling

- Bull Riding
- Slack
- Team Roping
- Barrel Racing
- r. Additional pens for housing stock if needed
- s. Accommodations for contractor personnel
- t. Six (6) flag horses for opening ceremony
- u. General Liability Insurance, Spectator Liability Insurance; and Utah Workers Comp.

Contractor shall provide the following for the Justin Boots Mutton Bustin:

- a. Provide Mutton Bustin' Sheep
- b. Helmets and Vests
- Bandanas and Buckles for Each Contestant
- d. Provide the winner of Each Performance with a Pair of Justin Boots
- 3. <u>Compensation and Payment.</u> The City of West Jordan will pay to Contractor \$72,000.00 in 2019 to be made within thirty (30) calendar days after the Event. For informational purposes, prior to receiving payment, Contractor shall provide City with a detailed written description of work performed and a detailed description of costs and expenses.
- 4. <u>Extra Services.</u> City shall not pay Contractor for any services, costs or expenses not specifically included in this Agreement unless expressly authorized, in writing, as extra services. Unless the City and Contractor have agreed in writing before the performance of extra services, no liability and no right to claim compensation for such extra services or expenses shall exist.
- 5. Services by the City. The City shall perform the following services, at City's sole expense:
- Arena, including clean up, EMS, security, and ticket sales
- b. Existing pens for housing stock. Additional pens must be supplied by Contractor if needed.
- Sound System
- c. PRCA Judges
- d. Prize Money for PRCA and WPRA Contests
- e. WPRA and PRCA Dues and Sanction Fees
- f. Rodeo Office for Secretary
- g. Tractor for the Arena. A Tractor Operator may be provided if available.
- h. Specialty Act (Contractor will assist City in finding a good specialty act)
- i. Veterinary Services
- j. Flag carriers (if desired)
- 6. <u>Assignment.</u> This Agreement is not assignable by Contractor, without the City's prior consent in writing.
- 7. Hold Harmless and Insurance.
 - A. Indemnity.

Contractor shall defend, indemnify and hold the City, its elected officials, officers, employees and volunteers harmless from all claims, lawsuits, demands, judgments or liability including, but not limited to, general liability, automobile and professional errors and omissions liability, arising out of, directly or indirectly, the negligent acts, errors and omissions of the Contractor in performing the services described.

B. Contractor's Insurance.

Contractor shall, at Contractor's sole cost and expense and throughout the term of this Agreement and any extensions thereof, carry insurance of the types and amounts indicated below.

- b. Except for Workers' Compensation, said insurance shall include as additional insured the following: The City of West Jordan, Utah, its officers, agents, employees and volunteers.
- c. Contractor shall procure worker's compensation coverage, as required by the statutes of Utah, for its employees during the performances and during the times between performances.
- d. All insurance policies shall be issued by a financially responsible company or companies authorized to do business in the State of Utah which are carry a Moody's rating of not less than A-. Within fourteen (14) calendar days after execution of this Agreement, Contractor shall furnish to City [Attn: West Jordan City Clerk, 8000 South Redwood Road, West Jordan, Utah 84088] an insurance certificate or other evidence of the required insurance.
- 8. Relationship of Parties and No Third Party Rights. This Agreement does not create any joint venture partnership, undertaking or business arrangement between the parties hereto nor any rights or benefits to third parties. The contractual relationship between the City and Contractor out of this Agreement is one of independent contractor and not agency. It is understood that Contractor shall not be deemed an employee of the City, and Contractor has no authority to enter into legally binding obligations on behalf of the City. It is specifically understood by the parties that: (a) the City has no interest in or responsibilities for or duty to third parties as a result of this Agreement, (b) Contractor shall have full power and authority over services performed subject to the obligations of Contractor set forth in this Agreement.
- 9. Expiration and Termination. This contract shall expire on December 30, 2019. This contract may be terminated, with cause, by either party in advance of the specified termination date, upon written notice being given to the other party. The party in violation will be given ten (10) working days after notification to correct and cease the violations, after which the contract may be terminated for cause. In the event that the City terminates the contract for cause, the City shall not be obligated to pay, and Contractor shall not be entitled to receive, any compensation for any services performed or costs incurred prior to such termination. This contract may be terminated by the City without

cause, in advance of the specified expiration date, upon 30 days written notice. In the event that the City terminates for convenience, Contractor shall cease performing services, and City shall pay to Contractor compensation for services actually performed and documented or costs actually incurred and documented prior to termination.

10. <u>Renewal.</u> This agreement may be renewed at the option of the parties upon written agreement for five (5) one-year contract renewals if desired at the agreed upon prices below:

- 11. Acceptance of Final Payment Constitutes Release. The acceptance by Contractor of the final payment made under this Agreement shall operate as and be a release to City from all claims and liabilities for compensation to, or claimed by, Contractor for anything done, finished or relating to the Contractor's work or services. Acceptance of payment shall be any negotiation of the City's check.
- 12. Waiver; Remedies Cumulative. Failure by a party to insist upon the strict performance of any of the provisions of this Agreement by the other party, irrespective of the length of time for which such failure continues, shall not constitute a waiver of such party's right to demand strict compliance by such other party in the future. No waiver by a party of a default or breach of the other party shall be effective or binding upon such party unless made in writing by such party, and no such waiver shall be implied from any omission by a party to take any action with respect to such default or breach. No express written waiver of a specified default or breach shall affect any other default or breach, or cover any other period of time, other than any default or breach and/or period of time specified. All of the remedies permitted or available to a party under this Agreement, or at law or in equity, shall be cumulative and alternative, and invocation of any such right or remedy shall not constitute a waiver or election of remedies with respect to any other permitted or available right or remedy.
- 13. <u>Assignment.</u> This Agreement shall not be assignable except at the written consent of the parties, and if so assigned, shall be binding upon the successors and assigns of the parties.
- 14. <u>Construction.</u> This Agreement shall be governed by and construed in accordance with the laws of the State of Utah.
- 15. <u>Integration.</u> Except for Contractor's written proposals for obtaining this Agreement, this Agreement contains the entire agreement between the parties with respect to the subject matter hereof and integrates all prior conversations, discussions or understandings of whatever kind or nature and may only be modified by a subsequent writing duly executed and approved by the parties hereto.
- 16. Future Appropriations. This Agreement shall not be construed in any manner to bind the

legislative or administrative discretion of the City or its future budget appropriations. The parties recognize that if this contract extends beyond the current fiscal year. Where future appropriations are unavailable or insufficient, the City may terminate this Agreement.

- 17. Construction of Language of Agreement. The provisions of this Agreement shall be construed as a whole according to its common meaning and purpose of providing a public benefit and not strictly for or against any party. It shall be construed consistent with the provisions hereof, in order to achieve the objectives and purposes of the parties. Wherever required by the context, the singular shall include the plural and vice versa, and the masculine gender shall include the feminine or neutral genders or vice versa.
- 18. <u>Mitigation of Damages.</u> In all situations arising out of this Agreement, the parties shall attempt to avoid and minimize the damages resulting from the conduct of the other party.
- 19. <u>Captions.</u> The captions or headings in the Agreement are for convenience only and in no other way define, limit or describe the scope or intent of any provision or section of the Agreement.
- 20. <u>Authorization</u>. Each party has expressly authorized the execution of this Agreement on its behalf and binds said party and its respective administrators, officers, directors, shareholders, divisions, subsidiaries, agents, employees, successors, assigns, principals, partners, joint ventures, insurance carriers and any others who may claim through it to this Agreement.
- 21. Representation Regarding Ethical Standards for City Officers and Employees and Former City Officers and Employees. The Contractor represents that it has not: (a) provided an illegal gift or payoff to a city officer or employee or former city officer or employee, or his or her relative or business entity; (b) retained any person to solicit or secure this contract upon an agreement or understanding for a commission, percentage, brokerage or contingent fee, other than as exempted in the City's Conflict of Interest ordinance; or (c) knowingly influenced (and hereby promises that it will not knowingly influence) a city officer or employee or former city officer or employee to breach any of the ethical standards set forth in the City's Conflict of Interest ordinance.
- 22. Equal Opportunity Clause. The Contractor agrees to abide by the provisions of Title VI and VII of the Civil Rights Act of 1964 (42USC 2000e) which prohibits discrimination against any employee or applicant for employment or any applicant or recipient of services, on the basis of race, religion, color, or national origin; and further agrees to abide by Executive Order No. 11246, as amended, which prohibits discrimination on the basis of sex; 45 CFR 90 which prohibits discrimination on the basis of age; and Section 504 of the Rehabilitation Act of 1973, or the Americans with Disabilities Act of 1990 which prohibits discrimination on the basis of disabilities. Also, the Contractor agrees to abide by Utah's Executive Order, dated June 30, 1989, which prohibits sexual harassment in the work place.
- 23. <u>Notices.</u> Any notice required to be given hereunder shall be deemed to have been given by depositing said notice in this United States mail, postage prepaid, or by facsimile with proof of transmission, and addressed as follows:

INTRODUCTION

West Jordan City is soliciting proposals for a Rodeo Stock Contractor for the 2019 Western Stampede PRCA Rodeo to be held July 4, 5, and 6. The city is seeking proposals from current eligible PRCA Rodeo Stock Contractors in good standing and current eligible PRCA Rodeo Production and Consulting firms, with expertise in providing top quality PRCA rodeos and family entertainment. The City anticipates entering into a one-year contract with the option of five 1-year contract renewals if both parties agree.

This Request for Proposal (RFP) provides guidance for Contractors to complete a proposal with specifications deemed pertinent for a proper proposal. All proposals submitted must be signed by Contractor and remain valid for 60 days following the due date of Proposals.

SPECIFICATIONS

STOCK

Contractors must demonstrate their PRCA/WPRA qualifications as a full stock contractor. The contractor selected by West Jordan City will be required to provide all working stock and stock management personnel necessary to conduct a PRCA/WPRA-sanctioned rodeo at Western Stampede Rodeo Grounds located in West Jordan, UT for a period of 3 days. The 2019 Western Stampede Rodeo will be held over the July 4 holiday.

All working stock shall be as fresh as possible for all events specified. A sufficient quantity of livestock must be provided by Contractor to ensure a comfortable margin of livestock for each event as specified by PRCA/WPRA rules.

Rodeo events to be held: Bareback Riding, Tie-Down Roping, Saddle Bronc, Steer Wrestling, Bull Riding, Team Roping, & Barrel Racing

Contractor shall describe their ability to provide and care for livestock according to PRCA/WPRA rules, including arrangements for feed and bedding of rodeo stock.

Contractor must produce a minimum of three of the top 50 rodeos in the PRCA (based on total PRCA combined purse standings).

Contractor must demonstrate the ability to market the Western Stampede through various social media platforms, including Facebook, Instagram & Twitter.

EVALUATION CRITERIA

The City of West Jordan will ultimately select one Contractor after evaluating all proposals. Proposals will be evaluated using the following criteria:

OPENING OF PROPOSALS

<u>Receipt and Registration of Proposals</u> will be handled by the City Recorder. On the closing date and time, proposals shall be opened publicly, identifying only the names of the proposing Contractors.

Proposals, modifications, or corrections received after the closing time on the "Due Date" will be considered late and will not be opened. Facsimile or email transmitted RFPs will not be considered.

If only one proposal is received in response to the RFP, the purchasing agent, based on feedback from the department, may either make an award or, if time permits, re-solicit for the purpose of obtaining additional proposals.

SUBMITTAL REQUIREMENT

Five (5) copies of the technical proposal and one copy of the sealed fee proposal shall be submitted to the City Recorders office, 3rd Floor City Hall, 8000 South Redwood Road by 2:00 p.m. on Tuesday, October 2, 2018.

A selection committee shall review the submitted material.

REJECTION OF PROPOSALS

The City reserves the right to reject any or all proposals received, and to select the proposal deemed to be the most advantageous and in the best interest of the City. Non-acceptance of a proposal will mean that one or more others were deemed more advantageous to the City or that all proposals were rejected. Applicants, whose proposals are not accepted, will be notified after a binding contractual agreement between the City and the selected applicant is executed, or when the City rejects all proposals.

FORMATION OF THE AGREEMENT WITH THE SELECTED APPLICANT

After selecting an applicant, the City may conduct additional negotiations with the applicant to arrive at a best and final offer. When both parties are in agreement, a contract will be awarded.

CONTRACT TERMS AND CONDITIONS

The successful Contractor will be required to enter into a contract with West Jordan City, which will contain, inter alia, the following contract provisions:

Performance Standards: Except as otherwise expressly provided, the Contractor shall fully perform all contracted work and services in a timely and skillful manner and in accordance with this Contract, and all prevailing industry standards and customs.

Contract Time: Contractor shall fully complete the Contract Work in a timely manner after execution of the Contract.

Renewal: Contract award shall be for one year with an option of five 1-year contract renewals if both parties agree.

Indemnification: Contractor agrees to indemnify, protect, defend and hold harmless West Jordan City, its agents and employees from and against all claims, demands, causes of action of any kind or character, including the defense thereof, arising out of the act, omission, negligence or intentional acts of Contractor's agents, employees, representative, assigns, and subcontractors under this contract.

Waiver: Failure of either party to enforce any of the provisions herein shall in no way be construed to be a waiver of such provisions. Such failure shall not in any way affect the right of either party

to thereafter enforce each and every provision of the contract. No waiver of any breach of any provision of this contract shall constitute a waiver of any other subsequent breach of any provision of this contract.

Entire Agreement and Modification: This contract constitutes the entire understanding of the parties and supersedes any and all prior written or verbal representations between the parties. This agreement cannot be modified unless said modification is reduced to writing and executed by both parties.

Independent Contractor: For the purpose of this Contract, it is understood that the parties are independent contractors and no employee or agent of one is, for any purpose of this contract, and employee or agent of the other. Nothing contained herein, or any of the obligations of the parties hereunder, shall in any manner inure to the benefit of third parties. Personnel under this Contract shall be mutually approved but are deemed for all purposes as employees or subcontractors of Contractor and as such, West Jordan City assumes no liability or responsibility for any wages, tax or insurance obligations on their behalf.

Workers Compensation Insurance: Contractor shall obtain and maintain during the entire term of this contract workers compensation coverage sufficient to cover all of Contractor's employees hereunder pursuant to Utah State statues. Contractor shall provide a certificate of insurance verifying that Contractor has complied with this requirement.

State and Federal Regulations: Contractor shall perform this contract in compliance with all applicable Utah state and federal laws, ordinances, and regulations.

Severability of Provisions: If any provisions of this contract are held invalid, the remainder of the contract shall not be affected thereby if such remainder would then continue to conform to the terms and requirements of applicable law.

Non-Assignability: Contractor shall not assign any interest in this contract, and shall not transfer any interest in this contract without written consent of the West Jordan City hereto.

Successor: The parties covenant that the provisions of this contract shall be binding upon heirs, successors, sub-contractors, representatives, and agents.

PROTECTED INFORMATION

The Government Records Access and Management Act (GRAMA), Utah Code Ann., Subsection 63G-2-305, provides in part that:

The following records are protected if properly classified by a government entity:

- (1) trade secrets as defined in Section 13-24-2 if the person submitting the trade secret has provided the governmental entity with the information specified in Section 63G-2-309 (Business Confidentiality Claims);
- (2) Commercial information or non-individual financial information obtained from a person if:

- (a) Disclosure of the information could reasonably be expected to result in unfair competitive injury to the person submitting the information or would impair the ability of the governmental entity to obtain necessary information in the future;
- (b) The person submitting the information has a greater interest in prohibiting access than the public in obtaining access; and
- (c) The person submitting the information has provided the governmental entity with the information specified in Section 63G-2-309;

(6) records the disclosure of which would impair governmental procurement proceedings or give an unfair advantage to any person proposing to enter into a contract or agreement with a governmental entity, except that this Subsection (6) does not restrict the right of a person to see bids submitted to or by a governmental entity after bidding has closed;

An entire proposal may not be protected under a Claim of Business Confidentiality. The claim of business confidentiality must be submitted with your proposal on the form, which may be accessed at: http://www.purchasing.utah.gov/contract/documents/confidentialityclaimform.doc

To ensure the information is protected, the bidder must clearly identify in the Executive Summary and in the body of the proposal any specific information for which a bidder claims business confidentiality protection as "PROTECTED."

All materials submitted become the property of West Jordan, Utah. Materials may be evaluated by anyone designated by West Jordan as part of the proposal evaluation committee. Informative materials submitted may be returned only at West Jordan's option.

INCURRING COSTS

West Jordan City will not be liable for any cost that applicants may incur in the preparation of their proposals. Proposals should be concise, straightforward, and prepared simply and economically. Expensive displays, bindings, or promotional materials are neither desired nor required.
