Subject: Process Outline For Carrying Capacity Analysis

Background

The purpose of this memorandum is to provide background and some recommended next steps on the issue of carrying capacity as it relates to the Central Wasatch Commission (CWC) project area.

Despite decades of planning efforts and studies, research and ultimate decision making surrounding the recreational capacity of the Wasatch Cache National Forest remains a difficult task for the USDA Forest Service and others in the Central Wasatch Mountains. Through the Utah Department of Transportation's (UDOT) current EIS process, several stakeholders have asked that the issue of carrying capacity be looked at in concert with efforts to improve traffic congestion and transportation decision options.

At the April 17th Central Wasatch Commission Stakeholders Council Meeting, CWC Stakeholder Pat Shea made a motion that the Central Wasatch Commission further study the issue of carrying capacity prior to the Little Cottonwood Canyon EIS and Cottonwood Canyons Transportation Action Plan work. The motion was supported by a majority of the Stakeholders Council membership present.

Next Steps

In an effort to ensure the CWC Board is able to make an informed decision about additional carrying capacity analysis, CWC staff will be working with the USDA Forest Service, UDOT and other jurisdictional staff members to provide information and a process for action. Below is a draft timeline for commission input:

June 19th, 2019 CWC Stakeholders Council Meeting: Presentation from Stakeholders Council Vice Chair, Dr. Kelly Bricker (Director, University of Utah Parks, Recreation & Tourism Department), on academic research surrounding carrying capacity concepts, surveys available, and potential approaches to capacity determinations as it relates to the Central Wasatch Mountains. The Forest Service will have representatives available to answer questions that may arise as part of Dr. Bricker's presentation.

July 1st, 2019 CWC Public Meeting:

- Presentation from Stakeholders Council Vice Chair, Dr. Kelly Bricker (Director, University of Utah Parks, Recreation & Tourism Department), on academic research surrounding carrying capacity concepts, surveys available, and potential approaches to capacity determination as it relates to the Central Wasatch Mountains.
- Discussion led by the UWC National Forest Forest Supervisor Dave Whittikiend on carrying capacity as it relates to National Forest system lands.

July 17th CWC Stakeholders Council Meeting: Stakeholder discussion on carrying capacity. Forest Service representatives will be available to answer questions posed by the Stakeholders Council concerning Forest Service policies, process, and resource management.

August 5th, 2019 CWC Public Meeting: CWC staff will prepare a series of potential actions for CWC board consideration.
