The City Council and staff met in the Community Room, 108 South 100 East, Pleasant Grove, Utah.

5:00 P.M. WORK SESSION

1) Miss Pleasant Grove Royalty.

This item was discussed during the Regular Meeting.

2) Communities That Care (CTC) Program by Heather Lewis of the Utah County Department of Drug and Alcohol Prevention Treatment.

City Administrator, Scott Darrington explained that staff was approached by Heather Lewis about the City potentially joining the Communities That Care (CTC) program offered through the County. She was present to explain the program and what it would mean for Pleasant Grove to be

a part of it. He confirmed that Ms. Lewis met with Tamara Oborn and Danny Rowen as part of the Be Well Pleasant Grove group.

Heather Lewis, from the Utah County Department of Drug and Alcohol Prevention Treatment, explained that she met Representative Hawkins from Pleasant Grove at another meeting and he told her about the Be Well Pleasant Grove Program. They believed that joining the CTC would be a partnership that would strengthen and support what they are already doing. The CTC would be able to receive funding that they could use to support Be Well Pleasant Grove.

Malyce Warner, also with the County, presented a brochure with information about CTC. She clarified that the CTC is a process rather than a program. They intend to work with community members to help prevent substance abuse and suicide. The brochure also listed the five phases of the process and provided statistics from communities that implemented CTC.

Council Member LeMone asked for an example of what CTC would do in the community. Ms. Lewis explained that the City would hire a part-time Coordinator to help run the coalition. That person would have a coach from the CTC program that would help them through the steps listed. Together, they would gather community leaders and volunteers to help assess what the community was already doing. With that information, they would know what they need to focus on. The CTC is a nationwide program that had been around for over 30 years. The funds they receive will fully fund the part-time employee for one year. After that, the City would have to provide partial funding for the employee.

Council Member Jensen asked where the funding came from, and Ms. Lewis said that it was all from federal sources.

There was brief discussion about what it might cost the City to fund the employee after the first year. There wasn't room for a new employee in the 2019-2020 Budget, so they would have to consider that with the next fiscal year.

Mayor Fugal asked Ms. Lewis if they had spoken with Lindon or Cedar Hills yet and if it would be possible to combine the cities so that they are handled by one employee. Ms. Lewis indicated that they hadn't spoken to those cities yet. She recommended keeping the communities separate because each community has different needs.

Administrator Darrington requested that the work session adjourn early because there was an emergency at the pool that staff needed to attend to.
