

First Amendment to  
Independent Contractor Agreement  
(Governmental Affairs Consulting/Lobbying)

**THIS FIRST AMENDMENT TO INDEPENDENT CONTRACTOR AGREEMENT** (this "*Amendment*") is made effective 23 April 2019 by the **CENTRAL WASATCH COMMISSION**, an interlocal entity and political subdivision of the state of Utah whose address is c/o 170 South Main Street, 15<sup>th</sup> Floor, Salt Lake City, Utah 84101 ("*CWC*"), and **DUTKO GLOBAL, INC.**, a Delaware corporation whose address is 100 M Street, SE, Suite 500, Washington D.C., 20003 ("*Contractor*"). CWC and Contractor are sometimes collectively referred to in this Agreement as the "*parties*," or individually as a "*party*."

**RECITALS:**

A. Effective 23 April 2018, the parties entered into an "Independent Contractor Agreement (Governmental Affairs Consulting/Lobbying)" (with all prior amendments, the "*Agreement*") concerning Contractor's provision of governmental affairs consulting/lobbying to CWC on the terms and conditions specified in the Agreement.

B. The parties now desire to amend the Agreement for the purposes specified in this Amendment. Unless otherwise defined in this Amendment, all capitalized "terms of art" in this Amendment shall have the same meanings and definitions as in the Agreement.

**AGREEMENT:**

**NOW, THEREFORE**, in consideration of the premises, the mutual covenants and undertakings of the parties hereto, and for other good and valuable consideration, the receipt and legal sufficiency of which is hereby acknowledged, the parties hereto acknowledge and agree as follows:

Section 1. **Amendment to Section 4.** The date of termination of the Agreement currently is 23 April 2018. The parties hereby agree to extend that termination date until 23 April 2020 (the "*Extension*"), so that the parties' respective rights and obligations under the Agreement shall continue through 23 April 2020 except as otherwise specified in this Amendment.

Section 2. **Amendment to Section 6.** During the Extension, Contractor's compensation under the Agreement shall be reduced from \$8,083.33 per month to \$5,000 per month, prorated for any partial months.

Section 3. **No Other Modification.** Except as specifically amended by this Amendment, the Agreement is unmodified and remains in full force and effect between the parties.
