## **Matters for Discussion**

1. 2019/2020 Budget Discussion. Council Chair Pender said at tonight's meeting the Council is going to go through the budget line by line and only ask questions of staff if needed.

Council Member Bynum emailed some questions to staff and City Engineer, Dennis Pay, and Lesly Allen from the Art's Council answered those questions.

Mr. Pay discussed the one time storm water funds and what that money will go towards.

Ms. Allen discussed what grant funds for the arts the City is anticipating and which grants require match funds.

Council Member Bynum wants the Council to consider raising the budget for the Art's Council in order to pay and intern or something else like that.

Council Member deWolfe thinks investing in the arts in the City is important. He also doesn't want to the City to lose good, talented employees so he doesn't want to see the Council cut salaries at all during this budget discussion.

Council Member Siwik is committed to keeping good talented public safety employees in the City and also funding storm drain infrastructure and making sure the City is compliant with storm water.

Council Member Thomas said funding public safety is her number priority and she would also like to see street lighting improved in the City.

Council Member Kindred would also like to see raises for public safety and making their wages competitive but is not willing to do a property tax increase to do that.

Council Member Mila said competitive pay for public safety and non-public safety employees is a top priority for her.

Council Member Bynum said that all City employees are the number one resource and she would like to see all employees taken care of. Storm water infrastructure is very important thing to focus on. The arts are also something she thinks is important to invest in because the arts make the City a better place.

Council Chair Pender said he agrees with the rest of the Council's priorities. He went over a cost of Police services around the Salt Lake Valley and said the cost of Police services in South Salt Lake are the highest. A copy is attached and incorporated by this reference.

The Council had a discussion on the cost of service numbers presented by Council Chair Pender.

Council Member Bynum would like the Council consider a property tax increase in addition to cutting the budget.

Council Member Kindred said that a majority of the Council has committed to not raising taxes so he would like to find the funds for a public safety increase within the budget.

Council Member Siwik said he and Council Member Thomas have found some cuts in the budget by going line by line.

Council Member Thomas said none of the cuts that were made touched any employee

salary amounts and no cuts were made to Police and Fire at all.

Council Members deWolfe and Bynum said that they don't want to raise property taxes but cutting the budget line by line is not sustainable year to year.

Mayor Wood said this budget has been worked on for the last four months. The budget has already been cut and it was cut last year as well and at this point she would like the Council to decide where these additional cuts will come from.

Council Member deWolfe would like to have an open conversation about raising taxes even it is at a lesser percentage. He wonders why four of the Council are so against raising taxes this year.

Council Member Kindred said that sales tax revenues are up significantly this year and the City should figure out a way to live within the means of the City.

Mayor Wood would like to hear from the Council what services they would like to see cut in the City in order to get to the \$1.6 million being proposed.

Council Chair Pender suggested the \$1.6 million be reduced. A 10% increase with a 2.75% merit increase seems like an obtainable amount for the Council to find within the budget.

Council Member Thomas thinks money could be saved with professional services and would like to see a City attorney brought before the Council in order to help with outside legal fees.

Mayor Wood said that the City has the same amount of attorneys it has always had and the cost of outside legal fees has gone down over the year not up.

Council Member Kindred had questions regarding the amount of money paid to Hoffman Law.

Deputy City Attorney, Hannah Vickery, said a bulk of the funds paid to Hoffman Law are paid for by developers.

Council Member Siwik went through the Administration budget line by line. Total amount out of the Administration budget was \$60,000.

The Council discussed the City Council budget next.

Council Member Kindred asked other surrounding cities if they paid any city staff out of the City Council budget and no other cities did. He doesn't want to pay any amount of the City Recorder salary out of the City Council budget.

Ms. Vickery said there are some statutory roles that the City Recorder carries for the Council.

The Council decided the budgeted amount paid for the City Recorder out of the Council budget should be moved into the Administration budget instead which would change the cuts to Administration to \$28,000

The total cuts to the City Council budget was \$135,000.

The Council discussed the Municipal Court budget. The cuts made in this department was \$3,000.

The Council discussed the City Attorney budget next.

The Council next discussed City Hall building. There was a cut of \$15,000.

The Council discussed public buildings budget and there was a cut of \$46,000.

The Council decided to cut the parking enforcement officer from the Urban Livability budget. Council Chair Pender thinks the Police Department can handle parking issues within their department.

Council Member Bynum has concerns about eliminating the parking enforcement position as there are many complaints from residents about parking in the City.

Mayor Wood said with the parking enforcement position would bring a new and different program to help address the issues near the high density locations.

The Council discussed the Streets Department. Council Member Siwik suggested cutting the part-time salary from \$24,000 to \$10,000.

Streets Division Manager, David Alexander, said he has had problems hiring employees for the streets department. The part-time salary is for two seasonal employees.

The total cut to the Streets Division is \$29,000.

The Council discussed the Engineering Department next. The cut to engineering was \$36,000.

The cut to Public Assets was \$6,000.

The cut to Community Development was \$53,000.

The cut to Parks and Recreation Department was \$3,000.

The Council discussed the community events next.

The amount the Council has cut so far is \$832,000 which equates to about and 8% increase for Public Safety employees.

The Council and staff discussed making cuts to the Capital Improvements funds and what repercussions that may cause.

Council Member Thomas suggested the Council cut the funds for the Baird and Helm project and a majority of the Council agreed.

Council Chair Pender asked about other areas of the Capital Improvement budget.

Council Member Kindred asked if there was a need to replace the PAL gym floor this year and repair the police department elevator.

Public Assets Director, Mont Roosendaal, explained the reason for these two projects.

Council Chair Pender suggested that the funds from the Scott School repair be transferred over to the Maxwell Lane project so a design review can be started on that project. He would also like to see funds go towards the rebranding and memorial at the Police station for Officer Romrell.

Council Member Kindred doesn't see a need to put a generator in the Columbus Center at this time.

Urban Design Director, Sharen Hauri, explained why the generator is important for the Columbus Center.

A majority of the Council decided the generator should stay in the budget.

Other funds were moved around the Capital Improvements fund to help fund projects of importance.

The percentage of raises for public safety that the Council came to with all the budget cuts was 13%.

The meeting adjourned at 9:26 p.m.
