Hi Katrina,

Thank you again for taking the time ahead of your workday to meet me at the site of the Mona City basketball court. We are really excited to be able to contribute to this initiative and with the City in bringing a great solution for the youth and active of Mona.

Based on the revised quote, it looks like Houweling's commitment needs to be \$21,000 just over double what the top end of the "Platinum Sponsor" level was on the initial fundraising. With that being the case I am hoping the team at Mona City would consider making Houweling's the "Title Sponsor" of the court. It is important to recognize all contributions, including \$5,000 from Rocky Mountain Power, \$1,000 from another sponsor (apologies I can't remember who that was) and the resources (land, site prep materials & equipment) contributed by but our hope is that Houweling's can be featured more prominently with the naming of the court. I quite like the idea of Houweling's Hoops and have included some mocked-up image that a sign could look like:



Personally I like the Mona City version in script font, but we of course would want to work with you and the City to put something together everyone is happy with.

Follow-up items we can connect on via email or on the phone:

- Is the Title Sponsor concept something Mona City would be comfortable with?
- Is the most recent quote subject to any potential cost overruns? I believe the only variable was site prep, which you noted Mona City was starting itself this week.
- What is the timeline required for payment of the funds? We can have a cheque made for partial or full donation amount depending on how the City would like it to be accounted.
