TOQUERVILLE CITY WATER CONSERVATION PLAN ORDINANCE 2010.XX



AN ORDINANCE AMENDING TITLE 8 PUBLIC UTILITIES, CHAPTER 4 OF THE CITY OF TOQUERVILLE MUNICIPAL CODE TO INCLUDE THE ADOPTION OF A WATER CONSERVATION PLAN.

RECITALS

WHEREAS, Toquerville City ("City") is an incorporated municipality duly organized under the laws of the State of Utah; and

WHEREAS, the City of Toquerville operates a culinary water system and is considered a retail water provider; and

WHEREAS, pursuant to Utah State Code 73-10-32 which requires all retail water providers to adopt a water conservation plan; and

WHEREAS, the City Council finds that water in an increasingly scarce source and the desire to promote water conservation programs and practices are vital to a growing community.

ORDINANCE

NOW THEREFORE, BE IT HEREBY ORDAINED by the City Council of Toquerville City, State of Utah, as follows:

CHAPTER 4: WATER CONSERVATION PLAN

8-4-1: PURPOSE:

The city council finds there is a need to adopt a water conservation plan to address water conservation programs and practices. The Plan shall be used in reviewing, approving, and administering requests for zone changes, conventional and phased subdivisions, development in commercial districts, and conditional use permits.

8-4-2: REQUIREMENTS:

The City shall adopt or modify a water conservation plan in compliance with Utah State requirements no less frequently than once every five years during a regularly schedule city council business meeting. Before adoption or amending the water conservation plan, the city shall hold a public hearing with reasonable and advance public notice. The adopted plan shall be filed with the Division of Water Resources.

REPEALER. This Ordinance shall repeal and supersede all prior ordinances and resolutions governing the same.

SAVINGS CLAUSE: If any provision or clause in this Ordinance or the application thereof to any person or entity or circumstance is held to be unconstitutional or otherwise invalid by any court of competent jurisdiction, such invalidity shall not affect other sections, provisions, clauses, or applications hereof which can be implemented without the invalid provision, clause, or application hereof, and to this end the provisions and clauses of this Ordinance are declared to be severable.

EFFECTIVE DATE. This Ordinance shall take effect immediately upon approved by the City Council.
