
The Tri-State ATV Club, a 501 (c3) charitable organization, is requesting a Temporary Use Permit to allow access to Grafton within the Town of Rockville by one of its 25 sponsored rides during the 2019 Tri-State Jamboree on March 19, 20 and 21, 2020. These rides occur primarily on Public lands and operate under appropriate permits or approvals.

The Gooseberry ride begins in Apple Valley and is limited to 20 participant units. The ride stops at various points of interest on the Mesa. The ride was permitted to visit Grafton town and cemetery site in March of this year. The ride would not proceed to the Grafton town site if the road access is muddy, as agreed this year.

The guides will carry first aid supplies, disposable sanitary bags, garbage bags and be equipped with two-way radios, cell phones and emergency contact information. The Jamboree has earned the respect from those that have granted permits and permission to include routes where rides have occurred during the past 15 years. We will continue to educate our participants on proper use of permitted routes and ethical riding protocol.

NONE - however: Each day 1 group with 3 guides (front, middle rear) descend from Gooseberry Mesa to GRAFTON. The guides carry first aid supplies, garbage bags and sanitary bags and keep participant vehicles on established travel ways. Speed will be limited to 15mph within the town.

Special Conditions of Temporary Use Permit:

- The temporary use will not create a hazard to the community.
- The existing right(s)-of-way will not be compromised at any time.
- All areas will be restored to conditions existing prior to the temporary use.
- Total liability for damages associated with the temporary use are that of the applicant.
- Dangerous materials will not be used or stored at the temporary use location.
- All appropriate licenses/permits will be secured by applicant prior to start of temporary use to include sales or service of alcohol, food, goods or other services. N/A
- Other conditions deemed appropriate by the Town of Rockville.
- A performance bond may be required.
