II. BUSINESS ITEM APPROVE THE MINUTES OF JUNE 12, 2019 AS PRESENTED

APPROVE RESOLUTION 19-121, SETTING THE 2019 PROPERTY TAX LEVY FOR THE FAIRWAY ESTATES SPECIAL SERVICE RECREATION DISTRICT YEAR 2019-2020

Danyce Steck explained that this action would set the 2019 property tax levy at the certified rate of .0101180, providing \$10,118 in revenue to the District. She recommended approving the rate as certified by the Salt Lake County Auditor and appropriating the \$18 revenue increase to Miscellaneous Services. There was mention of the fact that the published staff report included an incorrect tax rate of .001999 and an incorrect Resolution number of 19-122.

MOTION: Board Member McConnehey moved to approve Resolution 19-121, accepting the certified tax rate of .001180% as calculated by Salt Lake County. The motion was seconded by Board Member Lamb.
