RESOLUTION No. 2020-02

A RESOLUTION EXPRESSING GRATITUDE TO CHRIS McCANDLESS FOR HIS WORK AND SERVICE TO THE CENTRAL WASATCH COMMISSION

WHEREAS, at their regularly scheduled meeting on 6 January 2020, the members of the board of commissioners (the “*Board*”) of the Central Wasatch Commission interlocal entity (the “*CWC*”) took the opportunity to reflect on the exemplary service to the CWC of former Sandy City Councilmember Chris McCandless, who today returned to life as a private citizen following his decision not to run for re-election to the Sandy City Council; and

WHEREAS, during his time in public office, Chris worked diligently and innovatively to better Sandy City, Salt Lake County and the State of Utah; and

WHEREAS, one example of Chris’ exemplary public service was his active participation in the CWC to better assure the wise stewardship of the Wasatch mountain range in Salt Lake, Summit and Wasatch counties—including its watershed, recreational areas and natural beauty—so that future generations can continue to benefit from that wonderful and integral part of Utah’s natural environment; and

WHEREAS, Chris gave generously of his time, energy, talents and resources to further the purposes and goals of the CWC—including serving as the Chair of the Board for two years—and in so doing richly benefitted the CWC, its members and the present and future inhabitants of Utah’s “Wasatch Front” and “Wasatch Back;” and

WHEREAS, the value of Chris’ positive contributions to the CWC’s purposes and jurisdiction cannot be overemphasized; and

WHEREAS, consequently, the Board desires to express its profound appreciation to, and to honor Chris for, his diligent and selfless work on behalf of the CWC and all those who value the central Wasatch mountains;

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the Central Wasatch Commission that the Commission expresses its deep gratitude and appreciation to Chris McCandless for his diligence, work, vision and leadership concerning the CWC, with due acknowledgment of the support freely given by Chris’ wife Susan and their family to make such efforts possible.

This Resolution, assigned no. 2020-02, shall take immediate effect as soon as it shall be published or posted as required by law and deposited and recorded in the office of the Commission’s secretary, or such later date as may be required by Utah statute.
