Overview

 On Nov 13, 2019, the MSD Board of Trustees authorized the General Manager of the MSD to sign a municipal emergency management service and reimbursement agreement wit the Unified Fire Authority (UFA). As a result, two emergency management specialists were hired to provide weekly planning and training services as follows:

- Copperton = ½ day
- O White City = ½ day
- o Emigration Canyon = ½ day
- o Kearns = 1 ½ says
- o Magna = 2 days
- Unincorporated SL Co = ½ day
- \circ MSD = $\frac{1}{2}$ day


Emergency Operations Plan (EOP)

Continuity of Operations Plan (COOP)

- **HMP**—Identifies potential hazards in the county and helps ensure that all county jurisdictions, including the Townships, are in position to be eligible for pre and post disaster mitigations funds from FEMA.
- **EOP**—A comprehensive plan that establishes a framework to integrate and coordinate emergency response and recovery with government, volunteer, and private sector organizations for the affected jurisdiction.
- **COOP**—Ensures essential missions and functions of an organization may be performed with minimal disruption during an emergency event.




Current Tasks



- HMP—Currently being updated via a UFA contract with Integrated Solutions Consulting. Inputs have been provided by each jurisdiction in the County, including members of the MSD. Each jurisdiction will be linked to the base plan via their municipal annexes that will feature their respective hazard profiles and potential mitigation projects—estimated completion Spring 2020. MSD will adopt HMP via resolution within 12 months of County adoption of the plan.
- **EOP**—SL County EOP being updated. EOP for MSD, which includes member Townships and Towns, is in draft form—estimated completion Spring 2020. Links to HMP.
- COOP—Plan in draft form for MSD and each member Township and Town—estimated completion Summer 2020.



Training




- HMP, EOP and COOP Training—provided for trustees/mayor/councilmembers to review each plan and to review supporting templates, such as disaster notification and declaration templates—Summer & Fall 2020
- Emergency Coordination Center (ECC)—located at the UFA Emergency Management Facility, training will review roles and responsibilities in the event the ECC is activated for an exercise or real-world event—Summer/Fall 2020. Includes overview of WebEOC communications platform.
- Exercises—carry out discussion/table-top exercises with trustees/mayor/councilmembers and MSD leadership—Spring & Summer 2021.





Recurring Meetings

- Salt Lake Valley Emergency Manager Group Meeting—2nd Monday of each month. Provides updates on valley-wide emergency management issues, trainings, events, exercises, etc.
- Weekly Emergency Management Brief—Each Tuesday morning. Brief call provides any urgent updates as necessary between the monthly group meetings.
