ORDINANCE NO. 2020-1

AN ORDINANCE AMENDING SECTION 3-502, REVISED ORDINANCES OF PANGUITCH CITY, RELATING TO THE MEETING TIMES OF THE PANGUITCH CITY COUNCIL.

BE IT ORDAINED BY THE CITY COUNCIL OF PANGUITCH CITY, GARFIELD COUNTY, STATE OF UTAH, as follows:

1. Section 3-502, Revised ordinances of Panguitch City, is hereby amended to read as follows:

The governing body shall hold two (2) regular meetings, which shall be held on the second and fourth Tuesdays of each month at the Panguitch City Conference Room. The meeting on the second and fourth Tuesday of each month shall begin at 6:30 p.m. In addition, the following rule shall govern meetings following legal holidays, places of meetings and special meetings.

A. If the meeting is a legal holiday, then the meetings shall be held at the same time and place on the following day which is not a legal holiday, and

B. The governing body may, by resolution, provide for a different time and place for holding regular meetings of the governing body; and may, by order, provide for the time and place of holding special meetings of the governing body.

2. This ordinance shall become effective immediately upon passage and publication.

BE IT ORDAINED BY THE CITY COUNCIL OF PANGUITCH CITY, GARFIELD COUNTY, STATE OF UTAH, as follows:

1. The Utah Criminal Code, Utah Code Annotated (1953, as amended) 41-1-1, et seq., as amended through the 1997 General Session of the Utah State Legislature, is hereby re-adopted and incorporated by reference.
2. The Utah Motor Vehicle Act, Utah Code Annotated (1953, as amended) 41-1-1, et. Seq., as amended through the 1996 General Session of the Utah State Legislature, is hereby re-adopted and incorporated by reference.
3. The Utah Controlled Substances Act, Utah Code Annotated (1953, as amended) Title 58, Chapter 37, as amended through the 1997 General Session of the Utah State Legislature is hereby re-adopted and incorporated by reference.
4. This ordinance shall become effective immediately upon passage and publication.

WATER CONSERVATION PLAN ORDINANCE

**WATER CONSERVATION PLAN
PANGUITCH CITY, UTAH
A MUNICIPAL CORPORATION**

**AN ORDINANCE AMENDING PROVISION OF THE MUNICIPAL CODE
PERTAINING TO THE ADOPTION OF A WATER CONSERVATION PLAN.**

Section 1. Preamble

- A. WHEREAS, Panguitch City operates a culinary water system; and
- B. WHEREAS, the city council understands the pressing need to use water in a more efficient manner to allow for future sustained growth of the community;

Section 2. Ordaining Clause

NOW, THEREFORE, IT IS ORDAINED BY THE CITY COUNCIL OF PANGUITCH CITY, UTAH:

Section 4 Subsection 393 of the Panguitch City Municipal Code is hereby to read as follows:

Section 3. Water Conservation plan

The water conservation plan of Panguitch, adopted on the 1st, day of April, 2003, and revised on this 14th day of January, 2020, is hereby re-adopted. The plan will be amended no less than every five years and will continue to play a vital role in the future development of Panguitch, Utah.

ORDINANCE NO. 2020-4

AN ORDINANCE RE-ADOPTING THE DRINKING WATER SOURCE PROTECTION PLAN

BE IT ORDAINED BY THE CITY COUNCIL OF PANGUITCH CITY, GARFIELD COUNTY, STATE OF UTAH, as follows:

Section 1.

The purpose of this ordinance is to insure the provision of a safe and sanitary drinking water supply for the City by the establishment of drinking water source protection zones surrounding the wellheads for all wells which are the supply sources for the City water system and by the designation and regulation of property uses and conditions which may be maintained within such zones.

Section 2.

Establishment of drinking water source protection zones. There is hereby established use districts to be known as zones one, two, three, and four of the drinking water source protection area.

Section 3.

Permitted uses. The uses which shall be permitted where drinking water source protection zones are established.

Section 4.

Prohibited uses. The uses or conditions which shall be prohibited where drinking water sources protection zones are established.

Section 5.

Administration. The policies and procedures for administration of any source protection zone established under this ordinance shall be the same as provided in the existing zoning ordinance for the City of Panguitch.
