STAFF RECOMMENDATION:


Staff recommends approving the attached Resolution consenting to the appointment of Cindy Quick as City Recorder.



RESOLUTION 20-08

A RESOLUTION OF THE CITY COUNCIL CONSENTING
TO THE MAYOR'S APPOINTMENT OF A CITY RECORDER

Whereas the Mayor is authorized, with the advice and consent of the City Council, to appoint a City Recorder for the City of West Jordan; and

Whereas Mayor Burton has directed city staff to establish an open and competitive process for the recruitment of a City Recorder; and

Whereas Mayor Burton and the administrative staff most affected by the position of City Recorder have completed numerous interviews with several highly qualified candidates, and Mayor Burton has appointed Cindy M. Quick as the City Recorder for the City of West Jordan; and

NOW, THEREFORE, IT IS RESOLVED BY THE CITY COUNCIL OF WEST JORDAN, UTAH:

Section 1. Pursuant to the provisions of West Jordan City Code Subsections 1-6-5A3 and 1-7-4D, the City Council hereby consents to the appointment of Cindy M. Quick as the City Recorder for the City of West Jordan.

Section 2. The City Council's consent of the Mayor's appointment is contingent upon the satisfactory completion of all required city processes being completed prior to hiring.

Section 3. This Resolution shall take effect immediately.
