#### **Matters for Discussion**

1. UDOT – Pedestrian Safety Update. Lisa Zundel, Traffic Operations Engineer with UDOT, stated that since the men's resource center has opened on 3380 South 1000 West, there has been a lot more pedestrian traffic in the area and there have been some incidents with pedestrians. Council Members Thomas and Siwik met with UDOT leaders last week and discussed the issues. On Friday UDOT put up some message boards to remind drivers there are pedestrians in the area. They also put up some driver feedback signs that remind drivers of what the speed limit is, as well as flash the speed the drivers are going. They are going to put in a pedestrian hybrid signal which has a double red light that goes on solid when a pedestrian pushes the button. Then it starts flashing. The drivers should stop on the solid read lights. When it is flashing red they can go if the pedestrian has cleared their side of the roadway. They are also working to move the bus stop at 950 West to line up with the crossing so they won't have people jaywalking around the shelter. They hope that if they line up the bus stop with the signal the pedestrians will

utilize the signal rather than jaywalking.

They are also meeting with the resource center to work with them on opportunities for education of their patrons on how the signal operates.

They met with Rocky Mountain Power this week to get the lights currently installed along 3300 South repaired and to make sure they have the appropriate power source for the new signal. They will be facilitating that fairly quickly.

Council Member Bynum asked if there was any discussion about reducing the speed limit along 3300 South and asked if the current limit is 45 mph all along there currently.

Ms. Zundel confirmed the speed limit is 45 mph there and to this point in time they have not had any discussions about lowering it, but it is something they could do. Right now they are just trying to focus on getting the signal designed and installed. She could take that suggestion back to her group to look at.

Council Member de Wolfe asked what the timeline would be to get the signal put in.

Ms. Zundel answered that it is a little bit of an unknown currently. They are hoping sixty to ninety days. If things fall into place it could be sooner than that. They have to coordinate with Salt Lake County to get rights to install some things on their property now while they work through purchasing the property from them. The County is open and willing to work with them to make sure they get the appropriate easements and rights to be on their property before UDOT actually purchases the property.

Council Member deWolfe clarified that there are currently signs up that notify drivers of how fast they are going.

Ms. Zundel explained that they have some temporary signs up now that will likely be removed once the signal is in. They have the message boards that say "Pedestrians in the Area - Use Caution," and they have the signs that remind them of their speed and what the speed limit actually is. Once they get the signal in, they will remove some of those temporary features.

Council Member Siwik said what UDOT is doing is appreciated. To have them in sixty to ninety days is commendable.

Ms. Zundel clarified that it will be sixty to ninety days to the start of construction. They can get a signal like this constructed in about three to four weeks.

Council Member Thomas thanked Lisa for the update and for UDOT meeting with her and Council Member Siwik last week.

2. Elect Council Chair and Vice-chair for 2020. Council Member Siwik nominated Council Member Bynum to be council chair. Council Member de Wolfe seconded the nomination. There were no other nominations.

The most notable one is when the position was created to stand up the department, the director was a category one police officer and Utah Retirement Systems required staff to put language into the ordinance to protect his state retirement. This ordinance would remove that and update it.

ORDINANCE NO. 2020-
---------------------

AN ORDINANCE OF THE CITY OF SOUTH SALT LAKE CITY COUNCIL AMENDING CHAPTER 2.42 OF THE CITY OF SOUTH SALT LAKE MUNICIPAL CODE, TO CLARIFY THE URBAN LIVABILITY DEPARTMENT FUNCTIONS.

WHEREAS, the City established an Urban Livability Department to help ensure a livable urban community and to promote property pride and responsibility;

WHEREAS, the City Council finds that certain changes to Chapter 2.42 of the South Salt Lake Municipal Code is desirous to add clarity to the roles and responsibilities of the Urban Livability Director;

NOW THEREFORE, BE IT ORDAINED, by the City Council of the City of South Salt Lake as follows:

### Section I: Amend South Salt Lake Municipal Code Chapter 2.42 as follows:

Chapter 2.42 - URBAN LIVABILITY

Sections:

2.42.010 - Director of Uurban Livability—Appointment.

The department head of an the uUrban Livability dDepartment will be a category 1 law enforcement officer, shall be appointed, with the advice and consent of the Ceity eCouncil, reporting by and reports to the Mmayor.

2.42.020 - Duties.

The <u>Uurban ILivability Ddepartment</u>, under the direction of the <u>Uurban ILivability dDirector</u>, shall provide or coordinate community livability services in South Salt Lake City. These services are subject to the limitations of applicable funds <u>and</u> appropriations, statutes, and ordinances. These services include, but are not limited to, the following:

- Coordinate the enforcement of all municipal code sections relating to community livability, to include weed and other abatements, accumulated solid waste and litter, improper outdoor storage, storage of in-operable/un-registered vehicles, abandoned or vacant structures, graffiti removal, storm water, traffic calming, street lighting, public health complaints, zoning violations, snow removal, noise complaints, and so forth.
- 2. Oversee a code enforcement division, as directed by the Mmayor.
- 3. Under the Mmayor's direction, facilitate neighborhood, business district, and city department planning and problem-solving relating to community livability concerns.
- 4. Provide animal control services within the geographic boundaries of South Salt Lake City.
- 5. Provide fire marshal services with South Salt Lake City, to include ongoing business inspections, plan review, fire code enforcement, fire prevention education, a juvenile fire setter program, and related functions.
- 6. In conjunction with the public works director, recommend to the city council and mayor city-wide public works and infrastructure projects that enhance community livability.
- 7. In conjunction with the Ppolice Chief, promote the success of the city's landlord and tenant property programs.
- 8. Under the Mmayor's direction, facilitate city-wide livability initiatives in cooperation with the Ffire Cehief, pPolice eChief, pPublic Wworks Ddirector, eCommunity Ddevelopment

<u>dDirector</u>, <u>Ee</u>conomic <u>dD</u>evelopment <u>Ddirector</u>, <u>eCity <u>Aattorney</u>, and <u>P</u>parks and <u>rRecreation <u>dDirector</u>.</u></u>

**SECTION II.** Severability. If any section, subsection, sentence, clause, phrase, or portion of this ordinance is, for any reason, held invalid or unconstitutional by any court of competent jurisdiction, such provision shall be deemed a separate, distinct, and independent provision, and such holding shall not affect the validity of the remaining portions of this ordinance.

**SECTION III. Conflict with Existing Ordinances, Resolutions, or Policies**. To the extent that any ordinances, resolutions, or policies of the City of South Salt Lake conflict with the provisions of this ordinance, this ordinance shall prevail.

SECTION V. Effective Date. This ordinance shall become effective upon Mayor's signature and

publication, or after fifteen days of transmission to the office of the Mayor if neither approved nor disapproved by the Mayor, and thereafter, publication.
