The Provo City Planning Commission will hold a public hearing on Wednesday, June 12, 2013, at 5:00 p.m. in the Municipal Council Chambers of the Provo City Center, located at 351 West Center Street. The items listed below will be discussed, and anyone interested is invited to attend and provide comment. Preceding the public hearing, a briefing will be held at 4:30 p.m. in the Community Development Conference Room, located at 330 West 100 South. The briefing is open to the public; however, formal presentation of items, public comment and actions will be reserved for the public hearing at 5:00 p.m. in the Municipal Council Chambers. - ITEM 1* Brian L. Wolsey requests approval of a Zoning Map Amendment of approximately 1.10 acres, consisting of 7 lots, generally located along the east side of 500 West from 700 North to 800 North, from RC (Residential Conservation) zone to CG (General Commercial) zone in order to allow commercial development. *North Park Neighborhood* 13-0007R, Aaron Ardmore, 801-852-6404
- ITEM 2 Nathan Chappell, agent for Aspen Development, requests approval of a variance to Provo City Code, Section 15.04.030, Minimum Acreage Requirements, to permit a subdivision to be developed with less than the required 3 acres. The proposed subdivision will consist of 2.44 acres, and seven lots, generally located at 1306 North Geneva Road in the A1.5 (Agricultural) zone. *Lakeview North Neighborhood* 13-0005VB, Carrie Walls, 801-852-6413
