

UTAH BOARD OF PHARMACY ELECTRONIC MEETING

APPOINTMENTS:

RICHARD BALLAM- 3 YEAR (02/27/2018- 02/27/2021)

Mr. Ballam last met with the Board 10/22/2019, he was marked compliant at that meeting. Mr. Ballam is currently working at Larry's Smithfield Pharmacy. Supervisor reports are submitted in a timely manner, the reports indicate that he is doing well. At this time, Mr. Ballam would like to petition the Board for an early release from his probation. Mr. Ballam has submitted a letter with this request for the Board to review, he will be meeting today to discuss the request.

***NEW ORDER**

AURO PHARMACIES, INC- 5 YEAR, AS PER CALIFORNIA ORDER (03/24/2020- 03/23/2025)

Originally licensed to operate as a pharmacy and to dispense controlled substances in the State of Utah on or about 07/26/2012. On or about 08/03/2018, the California pharmacy license was sanctioned, pursuant to a "Decision After Rejection" issued by the California Board of Pharmacy. The misconduct also constitutes misconduct in the State of Utah. A fine was issued, the unstayed portion \$6,250.00, must be paid

within 6 months. A representative must meet with the Board annually or as the Division may direct. Respondent shall come into compliance with all statutes and administrative rules governing pharmacies in the State of Utah within 90 days of the Stipulation and Order, and shall timely submit documentation evidencing that compliance. Respondent may submit reports of compliance with the terms and conditions of the California disciplinary order to satisfy this requirement. Quarterly reports have been submitted for the Board to review. The Stipulation indicates the Respondent shall submit a corrective action plan, the Board may determine whether the California compliance reports will satisfy this requirement.

***NEW ORDER**

HRX PHARMACY- PUBLIC REPRIMAND, SIGNED 02/18/2020

A fine of \$20,700.00 is issued, of that total fine, \$10,350.00 shall be immediately stayed. If Respondent fails to correct deficiencies as described in the Stipulation and Order within 6 months, as determined by a future Division inspection, or fails to comply with any term or condition of the Stipulation and Order, then the Division may move to lift the stay and immediately impose the stayed portion of the fine.

Respondent shall submit a written practice plan, this has been received, and is available for the Board to review.

SAMUEL FLEGAL- 3 YEAR (05/18/2018- 05/17/2021)

Mr. Flegal last met with the Board on 10/22/2019, he was marked compliant at that meeting. Since the last meeting, all reports have been received. Mr. Flegal is currently working at Utah Poison Control Center. His most recent supervisor report will be available for the Board to review. The supervisor has indicated positive remarks on the report. Mr. Flegal has missed 7 check in's since our last meeting. His tests are negative. Mr. Flegal was issued a citation and a fine for missed check in's previously, and was urged not to have any more missed. Mr. Flegal understands that he will need to discuss the missed check in's with the Board at this time.
