Consideration of Resolution 20-25 Setting the 2020 Property Tax Rate.

**SUMMARY** (Brief synopsis of the of the issue)

Utah State Code §10-6-133 states:

- (1)(a) Before June 22 of each year, or September 1 in the case of a property tax rate increase under § 59-2-919 through 59-2-923, the governing body of each city, including charter cities, at a regular meeting or special meeting called for that purpose, shall by ordinance or resolution set the real and personal property tax levy for various municipal purposes.
- (b) Notwithstanding Subsection (1) (a), the governing body may set the levy at an appropriate later date with the approval of the State Tax Commission.

The District has received verbal approval from the State Tax Commission to set the tax rate on June 24. The proposed tax rate is not in excess of the tax rate certified by the Salt Lake County Auditor for tax year 2020.

TIME SENSITIVITY / URGENCY (Explain any deadlines, and the impact of those deadlines)

State code requires the property tax rate be set by resolution by June 22. The District has received permission by the Utah State Tax Commission to set the property tax rate on June 24.

#### **RESOLUTION NO. 20-25**

#### A RESOLUTION SETTING THE 2020 PROPERTY TAX RATE

WHEREAS, UTAH CODE ANN. Title 10, Chapter 6, Section 133 requires the governing body of each taxing entity set the real and personal property tax levy; and

WHEREAS, the District Board has determined the requirements of the fund for which property taxes are to be levied; and

WHEREAS, the property tax rate is not in excess of the tax rate certified by the Salt Lake County Auditor.

NOW, THEREFORE, BE IT RESOLVED BY THE WEST JORDAN FAIRWAY ESTATES SPECIAL SERVICE RECREATION DISTRICT BOARD:

- Section 1. For purposes of defraying the necessary and proper expenses of the West Jordan Fairway Estates SSRD and for maintaining the administration thereof, it is hereby determined that the rate of the West Jordan Fairway Estates SSRD property tax upon all real and personal property within the West Jordan Fairway Estates SSRD made taxable by law in the year 2020 for the District's fiscal year ending June 30, 2021 is set at a rate of 0.001132.
- Section 2. The District, by and through the District Board of the West Jordan Fairway Estates SSRD, hereby expressly reserves the power and right to amend the foregoing tax rate as it may deem just, proper, and appropriate under law.
- Section 3. The City Recorder shall submit a certified copy of this Resolution to the Salt Lake County Auditor on or before June 29, 2020.
  - Section 4. This Resolution shall take effect immediately upon adoption.
