**AN ORDINANCE OF THE CITY OF TAYLORVILLE PROVIDING FOR YEAR-END  
AMENDMENTS TO THE 2012-2013 FISCAL YEAR BUDGET**

**WHEREAS**, the Taylorsville City Council (the “*Council*”) met in regular session on June 12, 2013 to consider, among other things, amending the budget for the 2012-2013 fiscal year; and

**WHEREAS**, the City Administration has presented certain proposed amendments to the 2012-2013 fiscal year budget; and

**WHEREAS**, on May 15, 2013 notice of a public hearing to consider the recommended amendments to the 2012-2013 budget was published in the *Salt Lake Tribune* and *Deseret News*; and

**WHEREAS**, on June 5, 2013, a public hearing to receive public comment and consider the amendments to the 2012-2013 fiscal year budget was held at 6:30 p.m. in the Council Chambers located at 2600 West Taylorsville Boulevard, Taylorsville, Utah; and

**WHEREAS**, all interested persons in attendance at the public hearing were given an opportunity to be heard, for or against, the estimate of revenues and expenditures or any item thereof in the Tentative Budget; and

**WHEREAS**, it is the intent and desire of the City to comply with all applicable State and local laws regarding the adoption of and the amendments to the 2012-2013 fiscal year budget; and

**WHEREAS**, the Council finds that it has satisfied all legal requirements required to amend a budget.

**NOW, THEREFORE, BE IT ORDAINED** by the Council that the budget for the 2012-2013 fiscal year is hereby amended as set forth in the attached Exhibit “A” identified as 2012-2013 Amended Budget. This ordinance shall take effect upon passage and posting as required by law.
