The Daggett County Commissioners will hold two Public Hearings regarding their approval of Resolution No. 20-10 A RESOLUTION PROPOSING THE CREATION OF A LOCAL DISTRICT TO PROVIDE FIRE PROTECTION, PARAMEDIC AND EMERGENCY SERVICES (See Attached).

The First Public Hearing is on Wednesday, October 21, 2020, at 6:00 p.m. at the Daggett County Courthouse located at 95 North 1st West, Manila, Utah, 84046. The Town of Manila may or may not participate.

The Second Public Hearing is on Thursday, October 22, 2020 at 6:00 pm at the Dutch John Conference Hall located at 530 South Blvd; Dutch John, UT 84023. The Town of Dutch John may or may not participate.

If you cannot attend either hearing comments on the Proposed District will be accepted until 5:00 pm on October 22, 2020 at the Daggett County Clerk's Office at PO Box 400; Manila, UT 84046 or emailed to braymond@daggettcounty.org. RESOLUTION NO. 20-10

A RESOLUTION PROPOSING THE CREATION OF A LOCAL DISTRICT TO PROVIDE FIRE PROTECTION, PARAMEDIC AND EMERGENCY SERVICES.

WHEREAS, Daggett County, Utah (the "County"), is a political subdivision and body politic duly and regularly created, established, organized, and existing under and by virtue of the Constitution and laws of the State of Utah; and

WHEREAS, Pursuant to Utah Code §17B-1-202(1)(a)(iii) a local district may be created to provide fire protection, paramedic, and emergency services; and

WHEREAS, Pursuant to Utah Code §17B-1-203(1)(d) the process to create a local district may be initiated by "a resolution proposing the creation of a local district, adopted by the legislative body of each county whose unincorporated area, whether in whole or in part, includes and each municipality whose boundaries include any of the proposed local district"; and

WHEREAS, Daggett County has an obligation and responsibility to provide the vital services of paramedic, emergency services, and fire protection to the residents and visitors of Daggett County; and

WHEREAS, The Daggett County Board of Commissioners desires to improve the resources available to the emergency management department and increase their ability to provide these vital services to the residents and visitors to Daggett County; and

WHEREAS, The creation of a local district is one option that provides the opportunity to improve the quality of services provided; and

WHEREAS, The Daggett County Board of Commissioners proposes that the creation of a Local District for the purpose of providing fire protection, paramedic, and emergency services is in the best interest of the public health safety and welfare of the residents of Daggett County.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF DAGGETT COUNTY, UTAH AS FOLLOWS:

Section 1. The Daggett County Board of Commissioners hereby proposes that a local district be created, pursuant to Utah Code §17B-1-202(1)(a)(iii) to provide fire protection, paramedic, and emergency services to the unincorporated area of Daggett County.

Section 2. The Daggett County Board of Commissioners proposes that the boundaries of the local district shall be as shown on the map attached hereto as 'Exhibit A.'

Section 3. The Daggett County Board of Commissioners anticipates that the cost of providing the proposed services will be paid by a combination of monies received from the state for payments in lieu of taxes, other potential county donations, and/or a property tax levied by the newly created district.

Section 4. It is anticipated that initially, no tax will be necessary, resulting in no financial impact on a household located within the proposed district. However, in future years a property tax may become necessary. The estimated average financial impact on a household located within the proposed district will be approximately ninety-five dollars and thirty-nine cents (\$95.39) annually if the district board of trustees determines that a property tax is necessary and imposes a property tax levy at the maximum allowable tax rate.

Section 5. It is proposed that the local district be governed by a 5 member Board of Trustees. The initial board of trustees shall be appointed by the Daggett County board of Commissioners using the procedures established in Utah Code §17B-1-304. Subsequent members of the Board of Trustees shall be elected to 4 year terms, staggered as follows: Board members A, B, and C shall be up for election at the November, 2022 general election. Board Members D and E shall be up for election at the November 2024 general election.


