COMMISSIONER AINGE – WHEN I FIRST SAW THIS AND I SAW THE CONTRACT AMOUNT, I WAS A LITTLE BIT CONCERNED BECAUSE I KNEW THAT WE HAD RECENTLY ALSO CONTRACTED WITH ANOTHER CASE MANAGEMENT SYSTEM OVER THE LAST 6 MONTHS OR SO. SO, IT APPEARS THAT WE'RE DOUBLING UP BUT THEN I NOTICED THAT WE DO HAVE THE ABILITY TO TERMINATE THIS AGREEMENT AT ANY TIME. I JUST WANT TO MAKE SURE THAT THIS IS BUDGETED FOR AND HOW LONG WE'RE GOING TO BE RUNNING BOTH OF THESE SYSTEMS IN PARALLEL?

DAVE SHAWCROFT, DEPUTY COUNTY ATTORNEY – THE BOTTOM LINE IS THAT WE'RE TRYING TO IMPLEMENT ONE SYSTEM WHILE WE ARE USING THE OTHER AT THE SAME TIME SO THAT THERE'S AN OPPORTUNITY TO REMAIN IN BUSINESS MORE OR LESS.

I THINK WE'VE DONE THIS WITH SEVERAL OTHER SOFTWARE SYSTEMS THAT THE COUNTY HAS IMPLEMENTED INCLUDING WORKDAY BUT WE DID STRUCTURE THAT AGREEMENT, AS COMMISSIONER AINGE HAS MENTIONED, SO THAT WE HAVE THE ABILITY TO TERMINATE IT ONCE THE OTHER SYSTEM IS WORKING IN A MANNER THAT WE FEEL CONFIDENT – THAT WE'RE ABLE TO CONTINUE TO DO THE SERVICES AND NO LONGER NEED THE GENERAL TECHNOLOGIES. THAT'S THE BACKGROUND BEHIND IT.

AS FAR AS THE ACTUAL FUNDING – I DON'T HAVE SPECIFIC INFORMATION. WE COULD GET THAT TO YOU, BUT THIS JUST ALLOWS US TO CONTINUE TO OPERATE WHILE WE'RE IMPLEMENTING THE NEW FILEVINE SOFTWARE SYSTEM.

COMMISSIONER LEE - DAVE (SHAWCROFT), DO YOU HAVE AN ANTICIPATION ON HOW LONG THIS PROCESS WILL TAKE?

DAVE SHAWCROFT - WE DON'T. IF THERE'S A POSSIBILITY, WE'LL TAKE UNTIL THE END OF JUNE. WE HOPE NOT. THAT'S WHY WE HAVE THAT FLEXIBILITY BUILT INTO IT. I KNOW WHEN WE IMPLEMENTED THE JUSTWARE SYSTEM, I THINK IT TOOK A YEAR TO DO THAT. IT IS A COMPLICATED PROCESS, BUT WE ARE MOVING FORWARD AND HOPE TO GET IT IMPLEMENTED FULLY IN THE NEAR FUTURE.

COMMISSIONER AINGE - I APPRECIATE THAT EXPLANATION. I GUESS THE REMAINING QUESTION IS JUST DO WE HAVE FUNDS BUDGETED FOR THIS NEXT 6 MONTHS WHERE WE MAY BE IN PARALLEL?

DAVE SHAWCROFT - I DON'T KNOW THE ANSWER TO THAT. WE COULD HAVE HALEY GET YOU THAT INFORMATION, BUT I ASSUME THAT THERE ARE FUNDS BUDGETED, BUT I DON'T KNOW THAT.

COMMISSIONER AINGE - THAT'S AN IMPORTANT FACT FOR US TO FIGURE OUT BEFORE WE MOVE FORWARD WITH THIS.

IT MAY JUST HAVE BEEN THAT THERE WAS ENOUGH IN THE SINGLE LINE ITEM OF 'CASE MANAGEMENT SOFTWARE' FOR BOTH SYSTEMS BUT AS WE WENT THROUGH THE FILEVINE APPROVALS, I DIDN'T RECALL APPROVING ANYTHING RELATED TO JUSTWARE OR JOURNAL TECHNOLOGIES. I JUST WANT TO MAKE SURE IT'S THERE.




