A motion was made by Jeremy Haslam to delete current amendment (3) for the definition of "Contamination (High Hazard)". The motion was seconded by Don Simons and passed unanimously.

A motion was made by Linda Ebert to add a new amendment for Section 312.10.2 Testing. The new amendment would delete and replace the wording to read, "312.10.2 Testing. Reduced pressure principle, double check, pressure vacuum breaker, reduced pressure detector fire protection, double check detector fire protection, and spillresistant vacuum breaker backflow preventer assemblies shall be tested at the time of installation, immediately after repairs or relocation and at least annually. The Utah Cross Connection Control Commission has adopted the field test procedures published by the Manual of Cross-Connection Control, Tenth Edition. This manual is published by the University of Southern California's Foundation for Cross-Connection Control and Hydraulic Research. Test gauges shall comply with ASSE 1064." The motion was seconded by Don Simons and passed unanimously.

A motion was made by Don Simons to keep the current amendment to Section 303.4. The motion was seconded by Jeremy Haslam and passed unanimously.

A motion was made by Jeremy Haslam to table the decision for the current amendment for Section 311.1 until the next meeting. The motion was seconded by Linda Ebert and passed unanimously. Don Simon and Nelson Hooton will report on this at the next meeting.

A motion was made by Linda Ebert to keep the current amendment to Section 312.3. The motion
