#### **Minutes of February 17, 2021**

David Beck moved to approve the minutes from February 17, 2021. Seconded by Jaden Sorenson. Carries 5-0.

#### **Stella Torgerson- Building Permit**

Stella Torgerson is in attendance to get a building permit for a steel building at 155 West 400 North. Stella presented a plat map stating the setbacks. Setbacks were gone over and met Centerfield City's building code.

David Beck moved to approve a building permit for a steel building for Stella Torgerson at 155 West 400 North. Seconded by Jonah Christensen. Carries 5-0.

#### **Heber Flake- Building Permit**

Heber Flake is in attendance to get a building permit for a home at 100 West 345 North. Heber presented a plot map stating the setbacks. Setbacks were gone over and met Centerfield City's building code.

Jaden Sorenson moved to approve a building permit for Heber Flake for a home at 100 West 345 North. Seconded by Jon Hansen. Carries 5-0.

#### **Chase Argyle- Fence Building Permit**

Chase is in attendance to get a building permit for a fence at 65 south 400 East. Chase will get a signed agreement from his neighbor with property boundaries before the fence is installed.

Jonah Christensen made a motion to approve a fence building permit to Chase Argyle at 65 South 400 East. Seconded by Jackie Huff. Carries 5-0.

### **Merri Lynn Sorenson- Gunnison Valley Hospital Board Report**

Merri Lynn Sorenson is in attendance to give a quarterly report on the Gunnison Valley Hospital. The GVH is doing well. GVH has welcomed several new doctors, as well as lost a few this past year.

### **Lisa Williams- Irrigation Water**

Lisa Williams is in attendance to find out what happened with the irrigation shares of water that were supposed to be turned over to Centerfield City in Arno Jensen's subdivision. Currently the city shows no record of anyone in the Arno Jensen subdivision as owning shares of water. Talking to city attorney Kevin Daniels, he suggests that the residents need to get together and talk to the Estate about getting their shares of water.

The city is still trying to get the shares of water from Robert Child's and the Arno Jensen Estate. Mayor suggested everyone review the minutes from the time the subdivision was approved as well as the subdivision ordinance.

Garrick Willden from Jones and Demille has contacted Jon letting him know that Gunnison City would like to have a full building around the separator machine, because Gunnison's meter was vandalized. 

#### **Jaden Sorenson-**
