BEN VAN NOY, UTAH COUNTY DEPUTY ATTORNEY - SO AFTER DISCUSSION LAST WEEK AT COMMISSION MEETING TO CONTINUE THIS COMMISSIONER SAKIEVICH, WE SAT DOWN AND DISCUSSED SOME POTENTIAL CHANGES TO THIS BOND AGREEMENT. THE ONLY CHANGE IN THE VERSION THAT IS PUT ON THERE THAT IS DIFFERENT IS ON PARAGRAPH 7, THE LAST SENTENCE AND IT WOULD ESSENTIALLY BE EXCLUDING *INTENTIONAL AND NEGLIGENT ACTIONS* FROM THE COUNTY FROM THINGS THAT THE BATEMAN'S WOULD HAVE TO INDEMNIFY THE COUNTY FOR, FOR SOMETHING TO HAPPEN DURING THE TEARING DOWN OF THE BUILDING IF THAT BUILDING WERE TO BE TORN DOWN.

COMMISSIONER SAKIEVICH - BEN, WAS THERE AN ADDITIONAL ITEM THAT WE WERE GOING TO ADDRESS ON THIS PARTICULAR AGENDA ITEM THAT DAVE LEAVITT HAD POSTULATED AT THE TIME WHEN YOU AND HE AND I SPOKE?

BEN VAN NOY - MY RECOLLECTION WAS ON #7 - THE PERSON THAT NEEDED TO BE CHANGED.

COMMISSIONER SAKIEVICH - VERBALLY HE WAS MENTIONING THAT THIS SHOULD BE A COUNTY ATTORNEY DOCUMENT RATHER THAN A COMMISSION DOCUMENT. IS THAT THE CASE OR NOT?

BEN VAN NOY - NO, THIS CURRENT DOCUMENT BEFORE YOU WOULD BE SOMETHING FOR THE COMMISSION TO APPROVE.

COMMISSIONER SAKIEVICH - OKAY, SO WE'RE NOT GOING TO GO FORWARD WITH THAT. OKAY.

COMMISSIONER AINGE - SO, I WOULD PREFER THAT WE KEEP THE EXISTING LANGUAGE THAT WAS IN THERE ON THE ORIGINAL DRAFT. WHEN YOU HAVE A PRIVATE PROPERTY OWNER WHO IS IN NONCOMPLIANCE, WHO CAME TO THIS SETTLEMENT WITH THE COUNTY, THEY HAVE THEIR OWN ATTORNEY, THEY'VE AGREED TO THIS DOCUMENT, IN FACT THEY'VE ALREADY SIGNED THIS DOCUMENT, AND IT'S JUST FOR US TO SIGN THE OTHER SIDE. I CAN'T UNDERSTAND WHY WE WOULD EVER NEGOTIATE ON THEIR BEHALF AND MAKE IT EASIER FOR THEM TO SUE THE COUNTY, WHEN THEY'VE ALREADY AGREED TO IT AND SIGNED IT. SO I THINK WE NEED TO KEEP THE PROTECTIVE PROVISIONS THAT WERE IN THE FIRST DRAFT.

**COMMISSIONER SAKIEVICH - WHAT WAS EXPLAINED, AND WHAT WE DISCUSSED LAST WEEK WAS THAT AS WRITTEN, THE PARAGRAPH WAS IMPOSSIBLE TO ENFORCE, THAT IT COULD BE OVERTURNED. BECAUSE NO ENTITY OR INDIVIDUAL IS UNABLE TO SUE ANOTHER ORGANIZATION IF THEY WERE TO DELIBERATELY OR ACCIDENTALLY CAUSE HARM TO ANOTHER PARTY. AND SO THE LANGUAGE WAS ADDED TO SAY YES, WE HOLD YOU RESPONSIBLE ACCORDING AS OUTLINED, BUT NOTWITHSTANDING YOU CAN STILL COME BACK AND SUE US IN RETURN IF WE WERE TO CAUSE HARM TO YOU IN EXCHANGE. THE POINT HERE IS THE GOVERNMENT IS SERVING THE PEOPLE AND NOT THE PEOPLE SERVING THE GOVERNMENT WAS THE APPROACH I WAS TRYING TO TAKE WITH THIS. THAT WE ARE TRYING TO IDENTIFY ALL THE ISSUES AND TO ENSURE THAT WHATEVER WE SAY IN HERE IS ENFORCEABLE. AS THE PARAGRAPH WAS WRITTEN EARLIER IT WAS NOT ENFORCEABLE.**

**COMMISSIONER AINGE - SO AGAIN, I JUST I DON'T UNDERSTAND WHY? THEY'VE ALREADY SIGNED IT. THEY'VE ALREADY AGREED TO IT SO WHY, COMMISSIONER SAKIEVICH, INSTEAD OF NEGOTIATING ON BEHALF OF THE COUNTY ARE YOU NEGOTIATING ON BEHALF OF THE PRIVATE PROPERTY OWNER WHO HASN'T EVEN ASKED TO BE ADVOCATED FOR.**

**COMMISSIONER SAKIEVICH - WELL, IF ANYONE WERE TO ASK, I HAVE NOT RECEIVED A PENNY FROM THEM IN A DONATION. THAT ASIDE, I'M REPRESENTING BOTH THE COUNTY ORGANIZATION, THE COUNTY GOVERNMENT, AND ALSO REPRESENTING THE PEOPLE THEMSELVES THAT ARE AFFECTED. SO I'M TRYING TO BE AN ARBITER IN THIS TO MAKE SURE THAT BOTH PARTIES ARE WELL SERVED. AND IF I SEE A HOLE, THEN I WILL TRY TO ADDRESS IT AS I TRY TO DO THIS ONE AND I WOULD LIKELY DO IT IN THE FUTURE FOR OTHERS. AND SO THAT'S MY APPROACH. AGAIN, THE PARAGRAPH WAS UNENFORCEABLE AS EXPLAINED BY THE COUNTY ATTORNEY AND SO IT HENCE THEY ADDED THAT ADDITIONAL SENTENCE.**

**COMMISSIONER AINGE - THAT'S NOT THE ADVICE I'VE RECEIVED FROM COUNCIL BY THE WAY. THE CIVIL DIVISION, THAT THEY WOULD SAY THAT IT IS ENFORCEABLE. THERE MAY BE SOME ACTS WHERE WE WOULD NOT BE INDEMNIFIED BUT GENERALLY THE PROVISION IS ENFORCEABLE.**

**COMMISSIONER SAKIEVICH - WELL AGAIN, THE INITIAL DRAFT, EVEN IF IT WAS SIGNED EARLIER, TO ME WAS ONE SIDED. THEY USE A SLEDGEHAMMER INSTEAD OF A PENCIL TO DRIVE HOME A POINT, AND I'M INTERESTED IN BOTH THE COUNTY'S WELFARE AS A GOVERNMENT AND I'M ALSO INTERESTED IN THE WELFARE OF INDIVIDUALS THAT WE AS A COUNTY ARE SUPPORTING AND SERVING. AND SO I SAW THAT PARAGRAPH AS TOO ONE SIDED.**

**COMMISSIONER LEE - MAYBE I CAN MAKE A RECOMMENDATION TO IT. ON PARAGRAPH #7, THE ADDED LANGUAGE TO IT SAYS: "NOTWITHSTANDING THE SAME, BATEMAN'S SHALL NOT BE LIABLE OR INDEMNIFIED FOR DAMAGES OR INJURY CAUSED BY THE NEGLIGENCE OR INTENTIONAL ACTS OF THE COUNTY OR ITS AGENTS, REPRESENTATIVES, EMPLOYEES, OFFICIALS AND OTHER ANY CONTRACTOR HIRED BY COUNTY". WHAT IF WE TOOK AND STRUCK THE WORDS WHERE IT SAYS NEGLIGENCE OR AND WE STRUCK THAT OUT SO THAT IT WOULD**

**COMMISSIONER SAKIEVICH - I WANTED THE NEGLIGENCE, THE INADVERTENT ACTS OF COUNTY AGENTS TO BE INCLUDED IN THERE AS WELL, BECAUSE THERE ARE TIMES THAT WE MAY DO SOMETHING THAT WE DID NOT REALIZE THE OUTCOME FROM THOSE ACTS. AND SO IF WE HAD THE ACCIDENTAL ACTS, AS WELL AS THE INTENTIONAL ACTS INCLUDED IN THE LANGUAGE IT WOULD ASSURE THE BATEMANS TO BE WHOLE IF THEY NEED TO ASK FOR RELIEF.**

**COMMISSIONER AINGE - WHICH THE TAXPAYERS OF UTAH COUNTY WOULD THEN PAY FOR IN THAT INSTANCE.**

**COMMISSIONER SAKIEVICH - UTAH TAXPAYERS WOULD PAY FOR MY FAULTS IF I WERE TO CAUSE HARM TO THE BATEMAN FARMS AND SO I WOULD BE LIABLE TO THE UTAH COUNTY TAXPAYERS, YES.**

**COMMISSIONER AINGE - SO I WOULD MAKE A MOTION THAT WE APPROVE AGENDA ITEM NUMBER 12 WITH THE ORIGINAL VERSION THAT WAS ON LAST WEEK, WHICH HAS ALREADY BEEN SIGNED BY THE PROPERTY OWNER, APPROVED BY OUR COUNTY ATTORNEYS, RECOMMENDED BY OUR COUNTY ATTORNEYS.**

**COMMISSIONER SAKIEVICH - I WOULD LIKE TO PROVIDE AN ALTERNATIVE MOTION THAT IS -**

**COMMISSIONER LEE - LET ME SEE FIRST IF THERE'S A SECOND TO IT. I COULD SUPPORT THAT IF WE WERE TO STRIKE OUT THE NEGLIGENCE PART.**

**COMMISSIONER SAKIEVICH - WE HAVE TO SPEAK TO THIS FIRST?**

**COMMISSIONER LEE - YEAH, WE CAN GET THERE. WOULD YOU BE WILLING TO MODIFY THAT MOTION TO STRIKE THAT NEGLIGENCE PART OUT COMMISSIONER AINGE?**

**COMMISSIONER AINGE - I MEAN I COULD HAVE. I DON'T THINK IT WOULD HAVE BEEN THAT BIG OF A DEAL, BUT AGAIN, I JUST THINK THE PRINCIPLE OF THIS IS I DON'T FEEL THE NEED TO NEGOTIATE ON ANYONE'S BEHALF. THIS IS THE COUNTY NOW SIGNING THIS DOCUMENT, IT'S ALREADY BEEN APPROVED. IT WILL ACTUALLY TAKE OUR ATTORNEYS TIME AND MONEY TO GO AND MAKE THIS AMENDMENT SINCE THE OTHER SIDE IS ALREADY SIGNED IT. SO I DON'T REALLY UNDERSTAND WHY WE WOULD DO ANYTHING OTHER THAN SIGN THIS DOCUMENT.**

**COMMISSIONER LEE - RIGHT. I'LL SECOND IT FOR THE VOTE BUT THERE'S OBVIOUSLY CAN BE ANOTHER.**

**COMMISSIONER LEE - SURE.**

**DAVID LEAVITT - WHAT IS YOUR QUESTION? BECAUSE I CAME IN A LITTLE LATE.**

**COMMISSIONER SAKIEVICH - DO YOU HAVE A COPY OF THE ALTERNATE FORM OF PARAGRAPH 7?**

**DAVID LEAVITT - I'M SURE I CAN HAVE A COPY IN FRONT OF ME VERY QUICKLY. HAVE WE GOT A COPY OF IT? HERE YOU GO.**

**COMMISSIONER SAKIEVICH - I HAD SAID PREVIOUSLY TO YOU COMING IN HERE, WE HAD MET, YOU, BEN VAN NOY AND I, WE HAD TALKED THROUGH PARAGRAPH SEVEN, WHAT THAT MEANT. THAT WAS ONE OF TWO PARTS OF THAT MEETING, AND WE WERE TALKING THROUGH THAT IN MY PERSPECTIVE THAT THE COUNTY WAS COMING THROUGH AS *OUR WAY OR NO WAY* AND FOR THE RESIDENT AND THE OBJECTIVE OF THE COUNTY COMMISSION OR ANY OTHER ELECTED OR APPOINTED OFFICIAL IN THE COUNTY ROLE IS TO PROTECT THE INTEREST OF THE COUNTY, BUT ALSO PROTECT THE INTERESTS OF THOSE THAT FOR WHOM THEY ARE SUPPOSED TO REPRESENT, REGARDLESS TO WHAT DEPARTMENT THEY BELONG. AND THAT PARAGRAPH 7 TO ME, WAS TOO ONE SIDED AND WE SPENT PROBABLY ABOUT AN HOUR ON THIS.**

**DAVID LEAVITT - MEANING YOU AND ME?**

**COMMISSIONER SAKIEVICH - YOU AND I AND I THINK BEN TO SOME DEGREE.**

**DAVID LEAVITT - I MET WITH COMMISSIONER SAKIEVICH LAST WEEK ON THIS AND HAD MR. VAN NOY ON THE CONFERENCE CALL AS WELL. AND WE DISCUSSED THIS ISSUE AT LENGTH AND REALLY WHAT I BELIEVE I SAID DURING THAT TIME, WAS THAT AS A COUNTY COMMISSIONER AND AS A COUNTY ATTORNEY WE HOLD DUTIES TO A LOT OF PEOPLE. WE HOLD DUTIES TO THE GENERAL POPULACE, WE HOLD DUTIES TO INDIVIDUALS, WE ALSO HOLD DUTIES TO COUNTY GOVERNMENT AS THE ELECTED OFFICIALS OF THAT COUNTY GOVERNMENT. AND WHEN WE, BY THE VERY NATURE OF HOLDING DUTIES TO MULTIPLE PARTIES WHO HAVE CONFLICTING INTERESTS, WE CAN'T SATISFY THOSE DUTIES TO EVERYONE IN EVERY INSTANCE, SO YOU HAVE TO MAKE A CHOICE. WHAT I STATED WAS, IT IS MY BELIEF THAT INTENTIONAL ACTS OF A COUNTY OR NEGLIGENCE BY THE COUNTY ISN'T LIKELY TO BE ENFORCEABLE IN ONE WAY OR THE OTHER, BECAUSE IT'S AN INTENTIONAL ACT ON THE COUNTY AND THAT THIS IS OFTEN BOILERPLATE THAT IS INSERTED TO DISCOURAGE LITIGATION BUT ISN'T NECESSARILY ENFORCEABLE. DOES THAT COMPORT WITH WHAT YOUR RECOLLECTION WAS?**

**COMMISSIONER SAKIEVICH - YEAH, I THINK WHAT YOU WERE TRYING IN THAT RED PORTION WAS TO SAY THAT REGARDLESS OF WHAT WE ARE SAYING THAT YOU HOLD US THE COUNTY AND THEN INDEMNIFY US, THAT IT STILL DOESN'T PREVENT YOU FROM SEEKING LITIGATION IF WE CAUSE HARM.**

**COMMISSIONER SAKIEVICH - WE MEANING THE BATEMAN'S?**

DAVID LEAVITT - IF WE AS A COUNTY CAUSE HARM TO THE BATEMAN'S, IF THE COUNTY CAUSES HARM TO THE BATEMANS OR TO ANYBODY ELSE, THERE'S NOTHING HERE THAT WOULD PREVENT ANYONE INCLUDING THE BATEMAN'S FROM SUING US. WHETHER THE BATEMAN'S WOULD PREVAIL WOULD BE UP TO THE ENFORCEABILITY OF THIS CLAUSE. AND GENERALLY SPEAKING, I DON'T WANT TO SPEAK THAT SPECIFICALLY, OFTEN THESE SORTS OF CLAUSES ARE NOT ENFORCEABLE OR HAVE BEEN HELD NOT TO BE ENFORCEABLE BECAUSE THEY'RE DEALING WITH SOMEONE'S NEGLIGENCE OR AN INTENTIONAL ACT. AND SO IT'S LIKE I CAN'T INDEMNIFY IN CERTAIN INSTANCES AGAINST ME COMMITTING A CRIME FOR EXAMPLE, I MEAN THAT THAT'S NOT GOING TO GET ME OFF THE HOOK DESPITE THE FACT THAT SOMEONE SAYS I'LL HOLD YOU HARMLESS FROM YOUR ACTIONS. AT THE CORE OF THIS ISSUE IN MY MIND, IS THE QUESTION OF COMING UP WITH WHO IS ULTIMATELY OUR PRIMARY - TO WHOM DO WE OWE THE PRIMARY DUTY? AND I WOULD SAY, IF I CAN SPEAK MORE BROADLY ABOUT THIS ENFORCEMENT ACTION, THAT THAT ENFORCEMENT OF OUR ZONING ORDINANCE GENERALLY RESIDES WITH THE COUNTY ATTORNEY'S OFFICE NOT WITH THE COUNTY COMMISSION, I'M NOT SURE IN MOVING FORWARD, THAT WE OUGHT TO BE HAVING THE COUNTY COMMISSION ENGAGE IN THESE KINDS OF AGREEMENTS BECAUSE IT'S NOT YOUR ROLE TO ENFORCE THE ZONING ORDINANCE, IT'S MY ROLE AS THE COUNTY ATTORNEY. AND NOW THAT'S SOMETHING WE CAN SORT OUT IN FUTURE, RIGHT? NOW WE HAVE AN ENFORCEMENT AGREEMENT THAT'S BEEN SIGNED BY THE BATEMAN'S AND NOW WE HAVE 3 COUNTY COMMISSIONERS WHO ARE SIGNING THE ADDENDUM ON THIS BOND AND LIKE I TOLD YOU LAST WEEK COMMISSIONER SAKIEVICH, WE HOLD LOTS OF DUTIES TO LOTS OF PEOPLE BUT PRIMARILY WHEN YOU'RE SITTING IN YOUR ROLE AS A COUNTY COMMISSIONER, OUR ROLE IS TO LOOK OUT AFTER THE INTERESTS OF THE COUNTY. AND TO THE EXTENT THAT THAT VIOLATES YOUR CONSCIENCE, OR COMMISSIONER LEE'S CONSCIENCE OR COMMISSIONER AINGES CONSCIENCE, THEN YOU VOTE ACCORDINGLY. BUT FROM OUR PERSPECTIVE, OUR DUTY IS HOW WE WROTE IT. NOW I DIDN'T HAVE ANY PROBLEM OMITTING SOME OF THESE WORDS BECAUSE I'M NOT SURE THAT THEY'RE ENTIRELY ENFORCEABLE ANYWAY, BUT I DON'T HAVE ANY PROBLEM LEAVING THEM IN EITHER.

DAVID LEAVITT - WE'RE IN PARAGRAPH 7, RIGHT?

COMMISSIONER SAKIEVICH - YES, THEY ADDED LINE RED LINES WHICH I THINK YOU HAVE BLACK AND WHITE.

DAVID LEAVITT - NOT WITHSTANDING THAT BATEMAN SHALL NOT BE LIABLE TO INDEMNIFY FOR DAMAGES OR INJURY CAUSED BY THE NEGLIGENCE OR



AND NOT ONE COACH FROM COLORADO REPORTED BACK TO ME THAT THEY HAD KIDS TESTING POSITIVE OR KIDS THAT WERE SICK AFTER OUR EVENT. SO THEN I WENT TO UTAH AND THE UTAH HIGH SCHOOL ACTIVITIES ASSOCIATION. THEY'RE TESTING KIDS EVERY OTHER WEEK. I GOT THAT CALL FROM THE UTAH COUNTY HEALTH DEPARTMENT, ACTUALLY I DON'T THINK IT WAS COUNTY, WAS THAT THE STATE HEALTH DEPARTMENT, TWO WEEKS AFTER MY EVENT, WHICH MEANS THAT EVERY UTAH KID IN THE STATE THAT COMPETES HAD BEEN TESTED BETWEEN MY EVENT AND WHEN I GOT THAT PHONE CALL. SO I IMMEDIATELY SENT OUT AN EMAIL TO ALL THE COACHES IN UTAH AND ASKED, HEY I WANT YOU TO REPORT THAT YOUR KIDS HAVE TESTED, IF YOU HAD AN ATHLETE THAT TESTED POSITIVE AFTER MY EVENT, I WANT TO KNOW. I WANT TO COLLECT THAT DATA FOR MYSELF. I HAD TWO COACHES REPLY BACK THAT EACH HAD ONE ATHLETE. SO WHAT I WAS ABLE TO GATHER, THE DATA THAT I HAVE IS THAT AFTER MY EVENT I HAD TWO ATHLETES OUT OF 750 ATHLETES THAT TESTED POSITIVE AND THOSE TWO ATHLETES WERE ASYMPTOMATIC. AND YET I FELT LIKE THE UTAH HEALTH DEPARTMENT WANTED TO LABEL ME AS A SUPER SPREADER EVENT. AND THE UTAH HEALTH DEPARTMENT CALLED ME BECAUSE I WAS PRETTY PERSISTENT WITH MY OWN DATA GATHERING PROCESS, BUT I CONTACTED, THEY CONTACTED ME BACK A WEEK OR TWO LATER, I DON'T REMEMBER THE EXACT TIMEFRAME, BUT THEY SAID TO ME THEY SAID HEY WE WANT TO LET YOU KNOW THAT YOUR EVENT WAS DEEMED TO NOT BE, IT WAS NOT A SUPER SPREADER EVENT. AND THAT'S WHERE I LOOK AT THERE'S A YOUNG MAN, I KNOW IT'S I AGAIN I DON'T KNOW THEM PERSONALLY, BUT THAT TRIED TO HOLD THE EVENT SARATOGA SPRINGS, I KNOW THEY'RE TRYING TO HOLD ONE IN SPANISH FORK AND THEY KEEP GETTING SHUT DOWN, SHUT DOWN, IT'S THESE EVENTS THEY ARE WANTING TO LABEL THEM AS SUPER SPREADER EVENTS AND THEY SEEM TO BE SOMETIMES POLITICALLY MOTIVATED. IF YOU GATHER FOR THIS POLITICAL PURPOSE WELL WE'RE NOT GOING TO WORRY ABOUT WHETHER WE CALL YOU A SUPER SPREADER EVENT OR NOT. BUT IF IT'S FOR A PURPOSE THAT WE DON'T POLITICALLY DEEM**
