6.2 Review of Planning Commission Bylaws and Rules of Procedure for Consideration of Amendment

Kevin talked about the new changes as required from House bill 409. 4 hours of training are now required per year. The training and meeting attendance will be tracked by staff. Staff will also provide much of the training.

The Business Park Commission was removed from the bylaws and changed to committees. A commission member may be appointed to a committee by the Mayor or designee.

Commissioner Warner asked that 5.2 be clarified to state a quorum consist of 4 or more members and that a majority vote is required to pass a motion.

MOTION: Commissioner Beecher—To accept the current bylaws as proposed with the modifications as outlined. Motion seconded by Commissioner Morgan. Those voting yes Kirk Beecher, Ryan Frisby, Kathy Marzan, Tyler Moore, Kit Morgan and Blair Warner. The motion carried.

Commissioner Morgan has talked with several different county sheriffs. The apartment complexes and similar developments are taking a large amount of their recourses. He would like to have the chief of police to talk to us about how much of their resources are being taken up on calls to apartments and multi-unit developments.
