Mayor Randall called the meeting to order and welcomed all in attendance. The invocation was offered by Pastor Jimi Kestin and The Pledge of Allegiance to the Flag was led by Judy Bozeman.

Mayor Randall read a proclamation proclaiming April 30,2021 as Arbor Day.

Councilmember McArthur arrived.

Parks Manager Shane Moore mentioned Arbor Day events taking place later this month.

Budget and Financial Planning Manager Deanna Brklacich asked the Council if they had any questions regarding the proposed amendments as outlined in the agenda packet.

Mayor Randall opened the public hearing. There being no comment, she closed the public hearing.

DAYTIME IRRIGATION RESTRICTIONS:

Consider approval of daytime irrigation restrictions for those that irrigate with culinary water.

Water and Energy Conservationist Rene Fleming explained generally, this request is made annually in May. However, given the drought conditions the state is in, the levels of the local reservoirs, the Water Service Department is requesting daytime water restrictions for those that irrigate with culinary water. Staff is requesting that irrigation using culinary water be done between the hours of 8:00 pm - 8:00 am. It is recommended that customers complete watering before 4:00 am - 6:00 am as this is the time of day the system sees the highest demand. She noted that City and School District facilities irrigate with irrigation quality water; they will continue to water as the resources are available.

Mayor Randall reiterated if the sprinklers at those facilities are on during the day, it is because irrigation quality water is being used. She encouraged residents to kindly let their neighbors know about the restrictions when they are watering during the day.

Ms. Fleming added that parks and golf course staff have done a lot to improve their irrigation efficiency. She noted that residents use four times the amount of water outdoors as they do indoors. She then mentioned the Water District offers several rebate programs and provides suggestions on water conservation.

Water Services Director Scott Taylor explained the Utah Water Quality Board administers the Municipal Wastewater Planning Program. As part of the program, each wastewater treatment and collections entity is required to conduct a self-assessment of the condition of the wastewater system and the systems planning efforts. The self-assessment report is required to be adopted by the City Council through a resolution.

Case No. 2020-ZC-040

Planner Dan Boles presented the request to change the zone from R-1-10 to PD-R on approximately 24.11 acres located on the west side of the intersection of Canyon View Drive and Gap Canyon Parkway known as Rilassante at Divario (PA 3). He provided a PowerPoint presentation covering the following topics: vicinity map; zoning map; general plan map; original conceptual site plan; original landscape plan; original elevations; townhome concept; updated site plan (04/2021); updated elevations (apartments); elevations (townhomes); and renderings. He outlined the proposed parking.

Councilmember Larkin noted she and Councilmember McArthur toured the property and she feels much better about this proposed layout.

Mayor Randall commented that some of the letters received spoke about traffic on Canyon View Drive. The City's Public Works Director noted the traffic signal on Canyon View and Dixie Drive will be designed in the next fiscal year.

Councilmember Larkin pointed out when property is annexed into the City, it is zoned at a placeholder of R-1-10.

City Attorney Shawn Guzman advised there have been issues with hillsides being R-1-10 when annexed into the City. Currently, if property is annexed into the City, it comes in as agriculture unless there is a development agreement to zone it differently.

Consideration of a resolution to either accept or deny a Petition for Annexation for approximately 174 acres located west of Dixie Drive on the former Burt Burgess property.

City Attorney Shawn Guzman presented the Petition for Annexation for approximately 174 acres located west of Dixie Drive on the former Burt Burgess property. This property is west of the recent annexations at approximately 1600 South Dixie Drive. From the beginning, staff has insisted on the condition that the right of way for Gap Canyon Drive be dedicated; some of the roadway is on this

property. This item is the beginning of the annexation process. One of the conditions of approval that the full width of Gap Canyon Drive be dedicated to the City as well as a power easement. Staff has met with Matt Ence who represents the applicants. He recommended approval on the condition pertaining to the roadway and utility easement.

Mr. Ence explained he represents Husky Partners, LLC. He explained the Burgess properties are under contract to purchase with the intention of developing the properties. The applicants have gotten consent from the property owners to move forward with the annexation process. Once the roadway dedication plat is ready, the owners will sign it. He and staff are discussing what the property will be zoned as when annexed into the City.

City Attorney Shawn Guzman asked if the applicants have been in contact SITLA to determine if they wanted to annex their property to the west. He would like all of the property annexed at the same time.

Mr. Ence stated he will follow up with his clients to see if they were in contact with SITLA.

City Attorney Shawn Guzman explained that on May 2, 2019, the City of St. George and Washington County entered into an agreement titled: Interlocal Cooperation Agreement Regarding Election Services. The County and City have agreed to waive

the notice requirement for terminating the Interlocal Cooperation Agreement Regarding Election Services signed in 2019 and approve a new Interlocal Agreement for election services in its place. Since the previous election, the County has decided to change some of the terms of the interlocal agreement; however, they did not provide the proper notification. Rather than amending the original agreement, the County provided a new one. For this reason, he recommended waiving the notice requirements and to terminate the 2019 agreement and then adopt a new one.

He noted the former agreement expired. If issued, the renewal permit (2021 Permit) will last for 25 years unless renewed or amended. He explained that one change the Council approved at a recent meeting was the \$250 per acre fee for final plats.
