**REVIEW IPC SECTION 1002.1** 

The committee reviewed the changes to this section. Following the review, a motion was made by Don Simons to accept the changes for this section. The motion was seconded by Nelson Hooton and passed unanimously.

REVIEW REMAINING CHAPTERS OF THE 2021 IPC ALONG WITH CURRENT AMENDMENTS A motion was made by Linda Ebert to accept the changes in Chapter 11. The motion was seconded by Jeremy Haslam and passed unanimously. There are two amendments to this chapter. Following a review of the two current amendments, a motion was made by Linda Ebert to keep the two amendments. The motion was seconded by Don Simons and passed unanimously.

Page 2 of 4 Uniform Building Code Commission Plumbing Code/Health Advisory Committee April 1, 2021

Following a review of Chapter 12, a motion was made by Linda Ebert to accept the change in the 2021 code. The motion was seconded by Nelson Hooton and passed unanimously. There are no amendments to this chapter.

Following a review of Chapter 13, a motion was made by Don Simons to accept the changes. The motion was seconded by Linda Ebert and passed unanimously. The six amendments to this chapter were reviewed and the following motions were made.

A motion was made by Don Simons to keep the current amendment for Section 1301.4.1. The motion was seconded by Linda Ebert and passed unanimously.

A motion was made by Linda Ebert to keep the current amendment for Section 1301.5. The motion was seconded by Jeremy Haslam and passed unanimously.

Nathan Lunstad will work with the Cross Control Connection Commission on adding a new amendment for Section 1301.5.1 and including a definition for swing connection.

A motion was made by Linda Ebert to keep the current amendment for Section 1301.9.4. The motion was seconded by Don Simons and passed unanimously.

A motion was made by Linda Ebert to keep the current amendment for Section 1302.12.4. The motion was seconded by Jeremy Haslam and passed unanimously.

A motion was made by Linda Ebert to keep the current amendment for Section 1303.15.6. The motion was seconded by Nelson Hooton and passed unanimously.

A motion was made by Linda Ebert to keep the current amendment for Section 1304.4.2. The motion was seconded by Jeremy Haslam and passed unanimously.

A motion was made by Linda Ebert to add a new amendment to Chapter 15 that would delete reference standards ASSE 5013-2015, ASSE 5015 – 2015. ASSE 5020-2015, ASSE 5047-2015, ASSE 5048-2015, ASSE 5052-98, ASSE 5056-2015, CSA B64.10-17, and CSA B64.10.1-17. The motion was seconded by Don Simons and passed unanimously.

A motion was made by Don Simons to accept the reference section as modified. The motion was seconded by Jeremy Haslam and passed unanimously.

A motion was made by Jeremy Haslam to accept the changes in Appendix C. The motion was seconded by Linda Ebert and passed unanimously.

A motion was made by Don Simons to accept the changes in Appendix E. The motion was seconded by Nathan Lunstad and passed unanimously.

The decision for Appendix F and the excerpts for ICC A117-1-2017 was tabled for further review.

At the May meeting, the changes that have been recommended for the current amendments and new amendments that have been proposed will be reviewed again and then the committee will start the review of the ISPS code.
