

**RICH COUNTY COMMISSION  
MINUTES  
AUGUST 7, 2013**

The Rich County Commission Meeting was held on August 7, 2013 at the County Courthouse in Randolph, Utah beginning at 10:00 a.m. Those present were Chairman William E. Cox, Commissioner Norman A. Weston, Commissioner Thomas J. Weston and Clerk Rebecca Peart.

A motion was made by Tom Weston and seconded by Norm Weston and unanimously passed to approve the August 7, 2013 agenda as presented.

**Patti Fauver, Jennifer Yee and Tamara North with Utah Division of Drinking Water, Melissa Noble with the Attorney General Office** met with the Commission and presented a list of non-compliance issues with Mt. Meadows Subdivision water system. They stated they had been working with Mt. Meadows and they still were not in compliance. A 60 to 90 day compliance was worked out with the Commission.

**Cheryl Searle with the Drivers License Division** stated the contract with Rich County was going well. It is used for drivers license hearings. Norm Weston made a motion to approve the contract between Rich County and the State of Utah, Division of Facilities Construction and Management for a term of July 1, 2013 – June 30, 2018. Tom Weston seconded the motion and unanimously passed.

**Bruce Alder – Alder Family Subdivision** met with the Commission to request the Commission's signature on the **Alder Family Subdivision Plat**. He stated he had obtained all signatures required except the Commission. He informed the commission that he had met with the Board of Adjustments and he had an acknowledged right of way. A motion was made by Norm Weston to allow the Chairman's signature on the Alder Family Subdivision plat. Tom Weston seconded the motion and unanimously passed.

**Chad Booth with the County Seat** met with the Commission to inform them that the County Seat had won an award for their Wilderness Program. Mr. Booth gave a handout and a CD on what the show had presented. Funding and future episodes were discussed.

**Russell Thomson** met with the Commission to discuss the **maintenance of the Courthouse**. He will get hot water in the restrooms. The landscaping of the building was discussed. He felt it was too late to put water in a sprinkler system. The Commission stated they had received bids and were reviewing them. Russell gave a verbal job description of what he does.

**Kim Wilson Rich County Assessor** met with the Commission to discuss personal property exemptions. Assessor Wilson presented **personal property** exemptions that she had received. The Commissioners reviewed each application. Norm Weston made a motion to approve the personal property exemptions as presented. Tom Weston seconded the motion and unanimously approved.

A motion was made by Tom Weston seconded by Norm Weston and unanimously passed to award Trena Argyle the bid to **paint the outside entry of the Courthouse**. The bid amount is \$3075.00

Debra Ames Rich County Recorder presented the **Allgier Amended Subdivision Plat**. It is located at the Sweetwater Camper Trailer Park. The amendment is for lots 213 and 214 it changes the lot line. A motion was made by Tom Weston to approve the Subdivision amendment. Norm Weston seconded the motion and unanimously passed.

Commissioner Norm Weston made a motion to approve the July 3, 2013 **Minutes** and the motion was seconded by Commissioner Tom Weston and unanimously approved.

A motion was made by Tom Weston, and seconded by Norm Weston and unanimously passed to approve the **CURRENT EXPENDITURES** as presented.

With no further business before the Commission, the meeting adjourned.
